ENVIRONMENTAL HAZARDS

Difenoconazole is toxic to fish, mammals and aquatic invertebrates. Drift and runoff may be hazardous to estuarine/marine organisms in water adjacent to treated areas.

Azoxystrobin is toxic to freshwater and estuarine/marine fish and aquatic invertebrates. Azoxystrobin can be persistent for several months or longer.

Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Groundwater Advisory

Azoxystrobin and a degradate of azoxystrobin are known to leach through soil into groundwater under certain conditions as a result of label use. This chemical may leach into groundwater if used in areas where soils are permeable, particularly where the water table is shallow.

Surface Water Advisory

This product may impact surface water quality due to runoff of rain water. This is especially true for poorly draining soils and soils with shallow ground water. This product is classified as having a high potential for reaching surface water via runoff for several months or more after application. A level, well-maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential loading of Azoxystrobin and a degradate of Azoxystrobin from runoff water and sediment. Runoff of this product will be reduced by avoiding applications when rainfall or irrigation is expected to occur within 48 hours.

Notify State and/or Federal authorities and AXION AG PRODUCTS, LLC immediately if you observe any adverse environmental effects due to use of this product.

PHYSICAL OR CHEMICAL HAZARDS

Do not mix or allow to come into contact with oxidizing agents. Hazardous chemical reaction may occur.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

MANDATORY SPRAY DRIFT

Aerial Applications

- Do not release spray at a height greater than 10 ft above the vegetative canopy, unless a greater application height is necessary for pilot safety.
- Applicators are required to select nozzles that deliver Medium to coarse spray droplets in accordance with ASABE Standard S-572.1.
- Do not apply when wind speeds exceed 15 mph at the application site. If the windspeed is greater than 10 mph, the boom length must be 65% or less of the wingspan for fixed wing aircraft and 75% or less of the rotor diameter for helicopters. Otherwise, the boom length must be 75% or less of the wingspan for fixed-wing aircraft and 90% or less of the rotor diameter for helicopters
- Applicators must use ½ swath displacement upwind at the downwind edge of the field.
- Do not apply during temperature inversions.

Groundboom Applications

- User must only apply with the release height recommended by the manufacturer, but no more than 4 feet above the ground or crop canopy.
- Applicators are required to use a medium or coarser droplet size (ASABE S572.1).
- Do not apply when wind speeds exceed 15 miles per hour at the application site.
- Do not apply during temperature inversion

SPRAY DRIFT ADVISORIES

THE APPLICATOR IS RESPONSIBLE FOR AVOIDING OFF-SITE SPRAY DRIFT.

BE AWARE OF NEARBY NON-TARGET SITES AND ENVIRONMENTAL CONDITIONS.

IMPORTANCE OF DROPLET SIZE

An effective way to reduce spray drift is to apply large droplets. Use the largest droplets that provide target pest control. While applying larger droplets will reduce spray drift, the potential for drift will be greater if applications are made improperly or under unfavorable environmental conditions.

Controlling Droplet Size - Ground Boom

- Volume Increasing the spray volume so that larger droplets are produced will reduce spray drift. Use the highest practical spray volume for the application. If a greater spray volume is needed, consider using a nozzle with a higher flow rate.
- Pressure Use the lowest spray pressure recommended for the nozzle to produce the target spray volume and droplet size.
- Spray Nozzle Use a spray nozzle that is designed for the intended application. Consider using nozzles designed to reduce drift.

Controlling Droplet Size – Aircraft

Adjust Nozzles - Follow nozzle manufacturers' recommendations for setting up nozzles.
 Generally, to reduce fine droplets, nozzles should be oriented parallel with the airflow in flight.

BOOM HEIGHT - Ground Boom

For ground equipment, the boom should remain level with the crop and have minimal bounce.

RELEASE HEIGHT - Aircraft

Higher release heights increase the potential for spray drift.

SHIELDED SPRAYERS

Shielding the boom or individual nozzles can reduce spray drift. Consider using shielded sprayers. Verify that the shields are not interfering with the uniform deposition of the spray on the target area.

TEMPERATURE AND HUMIDITY

When making applications in hot and dry conditions, use larger droplets to reduce effects of evaporation.

TEMPERATURE INVERSIONS

Drift potential is high during a temperature inversion. Temperature inversions are characterized by increasing temperature with altitude and are common on nights with limited cloud cover and light to no wind. The presence of an inversion can be indicated by ground fog or by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing. Avoid applications during temperature inversions.

WIND

Drift potential generally increases with wind speed. AVOID APPLICATIONS DURING GUSTY WIND CONDITIONS. Applicators need to be familiar with local wind patterns and terrain that could affect spray drift.

PRODUCT INFORMATION

AX AZOXY-DIFEN is a broad-spectrum product containing two fungicides. It has preventative, systemic and curative properties and is recommended for the control of many important plant diseases. **AX AZOXY-DIFEN** provides excellent disease control of many leaf spots and powdery mildews. **AX AZOXY-DIFEN** is applied as a foliar spray and can be used in block, alternating spray or tank-mix programs with other crop protection products. All applications must be made according to the use directions that follow.

USE PRECAUTIONS AND RESTRICTIONS

FAILURE TO FOLLOW DIRECTIONS AND PRECAUTIONS ON THIS LABEL MAY RESULT IN CROP INJURY, POOR DISEASE CONTROL, AND/OR ILLEGAL RESIDUES.

ATTENTION

AX AZOXY-DIFEN is extremely phytotoxic to certain apple varieties.

AVOID SPRAY DRIFT. Extreme care must be used to prevent injury to apple trees (and apple fruit).

DO NOT spray **AX AZOXY-DIFEN** where spray drift may reach apple trees.

DO NOT spray when conditions favor drift beyond area intended for application. Conditions which may contribute to drift include thermal inversion, wind speed and direction, sprayer nozzle/pressure combinations, spray droplet size, etc. Contact your State Extension Agent for spray drift prevention guidelines in your area.

DO NOT use spray equipment which has been previously used to apply **AX AZOXY-DIFEN** to spray apple trees. Even trace amounts can cause unacceptable phytotoxicity to certain apple and crabapple varieties.

AVOIDING SPRAY DRIFT IS THE RESPONSIBILITY OF THE APPLICATOR.

Human flagging is prohibited.

USE INFORMATION

Application: Thorough coverage is necessary to provide good disease control. Make no more spray solution than is needed for application. Avoid spray overlap, as crop injury may occur.

Adjuvants: When an adjuvant is to be used with this product, the use of an adjuvant that meets the standards of the Chemical Producers and Distributors Association (CPDA) adjuvant certification program is recommended.

Use of Adjuvants: Under certain weather conditions (particularly high temperatures) AX AZOXY-DIFEN in combination with high rates of silicone-based or oil containing (petroleum or crop) additives or adjuvants may cause injury. Do not exceed 0.125% adjuvant (v/v). Consult an AXION AG PRODUCTS, LLC representative for more information concerning additives or adjuvants.

A tank mixture with Dimethoate may cause crop injury.

On fresh market tomatoes, do not use adjuvants or tank mix AX AZOXY-DIFEN with any EC product.

Efficacy: Under certain conditions conducive to extended infection periods, use another registered fungicide for additional applications if the maximum amount of **AX AZOXY-DIFEN** has been used. If resistant isolates to Group 3 or Group 11 fungicides are present, efficacy can be reduced for certain diseases. The higher rates in the rate range and/or shorter spray intervals may be required under conditions of heavy infection pressure, with highly susceptible varieties, or when environmental conditions are conducive to disease.

Integrated Pest Management (IPM): AX AZOXY-DIFEN should be integrated into an overall disease and pest management strategy whenever the use of a fungicide is required. Cultural practices known to reduce disease development should be followed. Consult your local agricultural authorities for additional IPM strategies established for your area. AX AZOXY-DIFEN may be used in State Agricultural Extension advisory (disease forecasting) programs which recommend application timing based on environmental factors favorable for disease development.

FUNGICIDE RESISTANCE MANAGEMENT

For resistance management, please note that **AX AZOXY-DIFEN** contains both Group 3 (difenoconazole) and Group 11 (azoxystrobin) fungicides. Any fungal population may contain individuals naturally resistant to **AX AZOXY-DIFEN** and other Group 3 or Group 11 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

As part of a resistance management strategy:

- Apply a maximum of 4 sprays during one crop cycle.
- Apply no more than 2 sequential applications unless otherwise stated in the crop section.
- Rotate the use of **AX AZOXY-DIFEN** or other Group 3 and 11 fungicides within a growing season sequence with different groups that control the same pathogens.
- Use tank mixtures with fungicides from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes scouting, uses
 historical information related to pesticide use, and crop rotation, and which considers host plant
 resistance, impact of environmental conditions on disease development, disease thresholds, as well

as cultural, biological and other chemical control practices.

- Where possible, make use of predictive disease models to effectively time fungicide/bactericide applications. Note that using predictive models alone is not sufficient to manage resistance.
- Monitor treated fungal populations for resistance development.
- Contact your local extension specialist or certified crop advisor for any additional pesticide resistancemanagement and/or IPM recommendations for specific crops and pathogens.
- For further information or to report suspected resistance contact company representatives at AXION AG PRODUCTS. You can also contact your pesticide distributor or university extension specialist to report resistance.

Crop Tolerance: Plant tolerance has been found to be acceptable for all crops on the label, however, not all possible tankmix combinations have been tested under all conditions. When possible, it is recommended to test the combinations on a small portion of the crop to ensure that a phytotoxic response will not occur as a result of application. See USE PRECAUTIONS AND RESTRICTIONS regarding apple phytotoxicity.

Greenhouse Use: For resistance management, do not use AX AZOXY-DIFEN for transplant production.

Spray Drift Management: To avoid spray drift, do not apply when conditions favor drift beyond the target area. The interaction of many equipment and weather-related factors determine the potential for spray drift.

AVOIDING SPRAY DRIFT AT THE APPLICATION SITE IS THE RESPONSIBILITY OF THE APPLICATOR AND THE GROWER.

MIXING AND APPLICATION METHODS

Spray Equipment

Nozzles

- Equip sprayers with nozzles that provide accurate and uniform application.
- Nozzles should be the same size and uniformly spaced across the boom.
- Calibrate sprayer before use.
- It is suggested that screens be used to protect the pump and to prevent nozzles from clogging.
- Screens placed on suction side of pump should be 16-mesh or coarser.
- Do not place a screen in the recirculation line.
- Use 50-mesh or coarser screens between the pump and boom, and where required, at the nozzles.
- Check nozzle manufacturer's recommendations.

Pump

- Use a pump with capacity to:
 - Maintain 35-40 psi at nozzles.
 - Provide sufficient agitation in tank to keep mixture in suspension this requires recirculation of 10% of tank volume per minute.
- Use a jet agitator or liquid sparge tube for agitation.
- Do not air sparge.

For more information on spray equipment and calibration, consult sprayer manufacturer's and state recommendations. For specific local directions and spray schedules, consult the current state agricultural recommendations.

Mixing Instructions

- **AX AZOXY-DIFEN** is a suspension concentrate (SC) formulation.
- Prepare no more spray mixture than is required for the immediate operation.
- Thoroughly clean spray equipment before using this product.
- Agitate the spray solution before and during application.
- Rinse spray tank thoroughly with clean water after each day's use and dispose of pesticide rinsate by application to an already treated area.

AX AZOXY-DIFEN Alone (No Tank Mix)

- Add 1/2 2/3 of the required amount of water to the spray or mixing tank.
- With the agitator running, add **AX AZOXY-DIFEN** to the tank.
- Continue agitation while adding the remainder of the water.
- Begin application of the spray solution after AX AZOXY-DIFEN has completely dispersed into the mix water.
- Maintain agitation until all of the mixture has been sprayed.

AX AZOXY-DIFEN + Tank Mixtures: AX AZOXY-DIFEN is usually compatible with all tank-mix partners listed on this label. To determine the physical compatibility of **AX AZOXY-DIFEN** with other products, use a jar test. Using a quart jar, add the proportionate amounts of the products to 1 qt of water. Add wettable powders and water dispersible granular products first, then liquid flowables, and emulsifiable concentrates last. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank.

It is the pesticide user's responsibility to ensure that all products are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture.

Mixing in the Spray Tank

- Add 1/2 2/3 of the required amount of water to the spray or mixing tank.
- With the agitator running, add the tank-mix partner(s) into the tank in the same order as described above.
- Allow the material to completely dissolve and disperse into the mix water. Continue agitation while adding the remainder of the water and **AX AZOXY-DIFEN** to the spray tank.
- Allow **AX AZOXY-DIFEN** to completely disperse.
- Spray the mixture with the agitator running.
- Observe all directions for use, crops/sites, use rates, dilution ratios, precautions, and limitations which appear on the tank mix product label.

- Label dosage rate must not be exceeded, and the most restrictive label precautions and limitations must be followed
- This product must not be mixed with any product which prohibits such mixing.
- It is the pesticide user's responsibility to ensure that all products are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture.

Application Instructions

AX AZOXY-DIFEN may be applied with all types of spray equipment commonly used for making ground and aerial applications. Proper adjustments and calibration of spraying equipment to give good canopy penetration and coverage is essential for good disease control.

Ground Application

- Apply in a minimum of 10 gal of water per acre, unless specified otherwise.
- Do not apply through any ultra-low volume (ULV) spray system.
- Thorough coverage is necessary to provide good disease control.

Aerial Application

- Use only on crops where aerial applications are indicated.
- Thorough coverage is necessary to provide good disease control.
- Apply in a minimum of 5 gallons of water per acre unless specified otherwise.
- Avoid application under conditions when uniform coverage cannot be obtained or when excessive spray drift may occur.
- Do not apply directly to humans or animals.
- Do not apply through any ultra-low volume (ULV) spray system.

ATTENTION

AX AZOXY-DIFEN is extremely phytotoxic to certain apple varieties.

AVOID SPRAY DRIFT. Extreme care must be used to prevent injury to apple trees (and apple fruit).

DO NOT spray **AX AZOXY-DIFEN** where spray drift may reach apple trees.

DO NOT spray when conditions favor drift beyond area intended for application.

Conditions which may contribute to drift include thermal inversion, wind speed and direction, sprayer nozzle/pressure combinations, spray droplet size, etc. Contact your State Extension Agent for spray drift prevention guidelines in your area. DO NOT use spray equipment which has been previously used to apply **AX AZOXY-DIFEN** to spray apple trees. Even trace amounts can cause unacceptable phytotoxicity to certain apple and crabapple varieties.

AVOIDING SPRAY DRIFT IS THE RESPONSIBILITY OF THE APPLICATOR.

Application Through Irrigation Systems (Chemigation)

- Use only on crops for which chemigation is specified on this label.
- Apply this product only through center pivot, solid set, hand move, or moving wheel irrigation systems. Do not
 apply this product through any other type of irrigation system.
- Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.
- Apply in 0.1-0.25 inches/acre. Excessive water may reduce efficacy.
- If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts.

- 5. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 6. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump), effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.

Center Pivot Irrigation Equipment

Notes: (1) Use only with drive systems which provide uniform water distribution. (2) Do not use end guns when chemigating **AX AZOXY-DIFEN** through center pivot systems because of non-uniform application.

- Determine the size of the area to be treated.
- Determine the time required to apply 1/8 1/2 inch of water over the area to be treated when the system and injection equipment are operated at normal pressures as recommended by the equipment manufacturer. When applying **AX AZOXY-DIFEN** through irrigation equipment use the lowest obtainable water volume while maintaining uniform distribution. Run the system at 80-95% of the manufacturer's rated capacity.
- Using water, determine the injection pump output when operated at normal line pressure.
- Determine the amount of **AX AZOXY-DIFEN** required to treat the area covered by the irrigation system.
- Add the required amount of AX AZOXY-DIFEN and sufficient water to meet the injection time requirements to the solution tank.
- Make sure the system is fully charged with water before starting injection of the AX AZOXY-DIFEN solution. Time
 the injection to last at least as long as it takes to bring the system to full pressure.
- Maintain constant solution tank agitation during the injection period.
- Continue to operate the system until the AX AZOXY-DIFEN solution has cleared the sprinkler head.

Solid Set, Hand Move, and Moving Wheel Irrigation Equipment

- Determine the acreage covered by the sprinklers.
- Fill injector solution tank with water and adjust flow rate to use the contents over a 20- to 30-minute interval.
 When applying AX AZOXY-DIFEN through irrigation equipment use the lowest obtainable water volume while maintaining uniform distribution.
- Determine the amount of **AX AZOXY-DIFEN** required to treat the area covered by the irrigation system.
- Add the required amount of AX AZOXY-DIFEN into the same quantity of water used to calibrate the injection period.
- Operate the system at the same pressure and time interval established during the calibration.
- Stop injection equipment after treatment is completed. Continue to operate the system until the AX AZOXY-DIFEN solution has cleared the last sprinkler head.

SPECIFIC INSTRUCTIONS FOR PUBLIC WATER SYSTEMS

- 1. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
- 2. - 6. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.
