### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Only for formulation into insecticides for the following uses: Residential Indoor (including pets) and Residential Outdoor restricted to building surfaces and spot treatments on structures, Indoor Food (food handling establishments) and Non-Food and Commercial, Industrial and Institutional as limited below.

Ready-to-use formulated products for use on pets eligible for re-registration must not contain more than 0.2% pyrethrins or 10% piperonyl butoxide or a percentage of N-octyl bicycloheptene dicarboximide that exceeds the following:

Shampoos -1.0% a.i. Sprays -2.5% a.i. Spot-on or Pour-on -1.0% a.i. Mousse, soap, lotion, roll-on, or gel -0.5% a.i. Comb -0.5% a.i. Wipe or rub -1.5% a.i. Towelettes -2% a.i.

#### Not for formulation into:

- wettable powder end-use products (EUP), unless the EUP is packaged in water soluble bags
- end-use products for use on Terrestrial food and non-food crops
- end-use products for Aquatic uses
- end-use products for use on Greenhouse food crops
- end-use products for Forestry uses
- end-use products for use as Post harvest sprays to food crops
- end-use products for use on Food producing animals or fowl (direct application to meat and dairy animals or their premises when occupied)

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** If container is damaged: Stop any leaks by repositioning the container or by patching or otherwise repairing the leaks. Take care to avoid contact with pesticide and wear protective gear. On cleanup of spilled liquids, wear protective equipment as required to prevent contact with the product or its vapors. Cover the spilled areas with generous amounts of absorbent material, such as clay, diatomaceous earth, sand, or sawdust. Sweep the contaminated absorbent on to a shovel and put the sweepings into a salvage drum. Dispose of wastes as below. Place leaking container into a similar drum or glass container. Does not store, use, pour, or spill near heat or open flame.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER DISPOSALHANDLING:** Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ½ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then, offer for recycling if available or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities.
