The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance

ENVIRONMENTAL HAZARDS

GROUND APPLICATIONS: This product is toxic to aquatic organisms, including fish and invertebrates. Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas. This product has a potential for runoff for several weeks after application. Poorly draining soils and soils with shallow water tables are more prone to produce runoff that contains this product.

This product is highly toxic to bees and other insect pollinators exposed to direct treatment on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds while bees or other insect pollinators are foraging the treatment area.

To protect the environment, do not allow pesticide to enter or runoff into storm drains, drainage ditches, gutters or surface waters. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Applying this product in calm weather when rain is not predicted for the next 24 hrs will help to ensure that wind or rain does not blow or wash pesticide off the treatment area. USE RESTRICTIONS

- Apply this product only as specified on this label.
- Do not apply more than 1 time/day.
- Only protected applicators may be in treatment area during application.
- Do not apply this product in a way that will contact workers or other persons, either directly or through drift.
- Do not remain in treated area. Exit area immediately and do not enter or allow others to enter treated area until sprays have dried, until vapors, mists and aerosols have dispersed, and the treated area has been thoroughly ventilated.
- Remove pets, birds and cover fish aquariums before spraying.
- When used as a direct or space spray, do not enter or allow others to enter until sprays have dried.
- For space sprays:
 - Do not allow adults, children or pets to enter the treated area for at least 15 min, until vapors, mists and aerosols have dispersed and the treated area has been thoroughly ventilated.
 - Do not remain in treated area. Exit area immediately and remain outside the treated area until aerosol, vapors and/or mists and aerosols have dispersed and the treated area has been thoroughly ventilated.
- Remove or cover exposed food and drinking water, in the treatment area, before application.

 1. Applications to soil or vegetation, as listed on this label, around structures;
 2. Applications to lawns, turf and other vegetation, as listed on this label;
 3. Applications to the side of a building, up to a maximum height of 3 ft above grade;
 4. Applications to underside of eaves, soffits, doors or windows permanently protected from rainfall by a covering, overhang, awning or other structure;
 5. Applications around potential pest entry points into buildings, when limited to a surface band not to exceed 1" in width;
 6. Applications made through the use of a coarse, low pressure spray to only those portions of surfaces that are directly above bare soil, lawn, turf, mulch or other vegetation, as listed on this label, and not over an impervious surface, drainage or other condition that could result in runoff into storm drains, drainage ditches, gutter or surface waters, in order to control occasional invaders or aggregating pests
 7. Not for use in outdoor residential misting systems.

PRODUCT INFORMATION

Note: Some furniture finishes, particularly plastics, can be damaged by petroleum-based insecticides. To avoid damage, cover those items and do not spray directly. If in doubt, test by applying this material to an inconspicuous area before spraying.

USE IN FOOD HANDLING ESTABLISHMENTS

Applications may be made in food/feed areas of food/feed handling establishments as a contact spray, space spray, crack-and-crevice treatment, including those operating under the Federal meat, poultry, shell egg grading and egg products inspection programs. Food handling establishments are places other than private residences in which food is held, processed, prepared or served. **FOOD AREAS:** Include areas for receiving, serving, storing (dry, cold, frozen, raw), packing (canning, bottling, wrapping, boxing), preparing (cleaning, slicing, cooking, grinding), edible waste storage and enclosed processing systems (mills, dairies, edible oils and syrups).

NON-FOOD AREAS: Include areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage areas (after canning or bottling).

Apply to pest(s) and sites under the Indoor Use section below. Do not make space spray applications to food areas when the facility is in operation. Prior to space spray applications, remove or cover exposed food and drinking water in the treatment area. Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, in the treatment area, wash them before use.

INDOOR USE

SPACE SPRAY APPLICATIONS FOR LISTED FLYING INSECTS: Use full strength or dilute as needed using the dilution chart below. Before treating, open cabinets, doors and equipment to be treated; turn off air conditioners and fans, extinguish all flames and pilot lights and close windows in the area to be treated. Apply using a mechanical aerosol generator (droplet size of < 50 microns in diameter and 80% < 30 microns). Apply undiluted at a rate of approximately 1 fl oz/1,000 ft³ of room space, or apply diluted at the rate of 1- 2 fl oz/1,000 ft³ of room space. In commercial operations, subtract the space occupied by stored product or equipment from the cubic footage. Disperse toward areas suspected of harboring the greatest infestations of listed pests. Disperse in all locations (including around equipment, appliances and pallets, if desired) contacting as many insects as possible. Do not remain in treated areas after application. Keep area closed for at least 1 hr. Open and thoroughly ventilate treated areas before reoccupying. Do not apply as a space spray in residences.

DILUTION: Use a white mineral oil conforming to regulation 21 CFR 178.3620(b) or an odorless light petroleum hydrocarbon conforming to 21 CFR 172.882 or 40 CFR 180.910 (Inert ingredients used pre and post-harvest; exemptions from the requirement of a tolerance) and 180.930 (Inert ingredients applied to animals; exemptions from the requirement of a tolerance.) Combine oil and concentrate as directed below and mix well just prior to application.

SPACE SPRAY APPLICATIONS FOR CRAWLING INSECTS (Beetles, Earwigs, Silverfish): Use full strength. Prior to treatment, open cabinets, doors and equipment to be treated; turn off air conditioners and fans, extinguish all flames and pilot lights and close windows in the area to be treated. Apply as a space spray using a mechanical aerosol generator (droplet size of <50 microns in diameter and 80% <30 microns) at a rate of 1 fl oz/1,000 ft³ of room space. In commercial operations, subtract the space occupied by stored product or equipment from the cubic footage. Disperse toward areas suspected of harboring the greatest infestations of listed pests. Disperse in all locations (including around equipment, appliances and pallets, if desired) contacting as many insects as possible. Do not remain in treated area after application and leave area closed for 1 hour. Ventilate thoroughly before occupants are allowed to re-enter. Do not apply as a space spray in residences.

DIRECT SPRAY OR VOID TREATMENTS: Use equipment designed for space or mist treatments, or void injector (such as Actisol® or Micro-Injector®). Follow the manufacturer's recommendations for proper equipment set up and operation. Place the tip of the applicator at or into the crack or crevice or opening to the void. Apply in short bursts into area being treated. Apply 1 sec of product for every 3 ft³ of void area. **For Direct Spray**, apply the product in short bursts into the area where insects are to be contacted, such as corners of the room, behind and under furniture or other equipment. Apply from a distance of 18 - 24 inches away from the surface and allow the material to drift to area to be treated. The amount of product applied is not to exceed 0.33 fl oz /1,000 ft³.

PINSTREAM APPLICATION: Apply directly into cracks and crevices and elements of construction such as walls, floors, underneath sinks, behind pipes and other places where insects harbor. For spot treatments, use a coarse, low-pressure spray. Limit spot treatments to an area no larger than 20% of the surface area. Any individual spot treatment shall not exceed 2 ft². Contact as many insects as possible. Before making any application, ensure product will not stain surface or leave an unacceptable residue. The amount of product applied is not to exceed 0.33 fl oz/2 ft².

OUTDOOR USE

OUTDOOR GROUND FOGGING APPLICATION USING HANDHELD EQUIPMENT: Use in open areas near buildings and in campgrounds. Use preferably at a time when temperature is cool ($\leq 75^{\circ}\text{F}$) and the wind velocity is approx. ≤ 5 mph. When using ULV equipment, apply at the rate of 4 fl oz/acre. Allow spray drift to penetrate dense foliage.

FOR USE ON DOMESTIC ANIMALS/LIVESTOCK

Use to protect beef cattle, dairy cattle and horses from horn flies, apply a light mist sufficient to wet the tips of the hair. To kill the motile stages of blood sucking lice on beef and dairy cattle, apply the spray to thoroughly wet the hair. Use 2 fl oz or less/animal and repeat every 2 - 3 weeks as required, but do not apply more than 1 time/day. **Do not use on dogs and cats.**

Space Treatment Over Animals in Barns, Private and Commercial, Corrals, Stables, Dairies, Poultry Houses and Other Animal Quarters to Control Pests: Select proper dilution or use undiluted and apply with appropriate fogging equipment over animals. Apply undiluted at a rate of approximately 1 fl oz/1,000 ft³ of room space, or apply diluted at the rate of 1- 2 fl oz/1,000 ft³. Direct the spray or mist towards the upper portions of the enclosure filling the room with spray or mist. Vacate treated premises and keep area closed if possible for 15 minutes. Ventilate area prior to re-entry. Repeat treatments when pest thresholds warrant reapplication.

Treatment of Bagged Foods: To kill accessible adult stages of Almond Moths, Angoumois Grain Moths, Cadelles, Cereal Beetles, Cheese Mites, Cheese Skippers, Chocolate Moths, Cigarette Beetles, Confused Flour Beetles, Crickets, Dark Mealworms, Drugstore Beetles, Earwigs, Firebrats, Grain Mites, Granary Weevils, Hide Beetles, Indian Meal Moths, Mediterranean Flour Moths, Red Flour Beetles, Rice Weevils, Saw-Toothed Grain Beetles, Silverfish, Small Flying Moths, Spider Beetles, Yellow Mealworms, Dried Fruit Beetles, Warehouse Beetles, Rusty Grain Beetles, Lesser Grain Beetles, Coffee Bean Weevils, Khapra Beetle and other listed pests, apply as a space spray at the rate of 1 fluid ounce/1,000 cu. ft. of space. Fumigate or destroy infested stored products or treat by other effective methods using an approved product intended for this purpose. Direct application to food contact surfaces is prohibited. Do not apply more than once per day.

Application to Vegetables (Potato, Tomato, Pea, Sweet Potato), Fruits (Apple, Blackberry, Blueberry, Boysenberry, Cherry, Crabapple, Currant, Dewberry, Fig, Gooseberry, Grape, Guava, Loganberry, Mango, Muskmelon, Orange, Peach, Pear, Pineapple, Plum, Raspberry), Nuts (Almonds, Peanuts, Walnuts) and other Commodities (Copra and Peanut): To kill accessible stages of Almond Moths, Angoumois Grain Moths, Cadelles, Cereal Beetles, Cheese Mites, Cheese Skippers, Chocolate Moths, Cigarette Beetles, Confused Flour Beetles, Crickets, Dark Mealworms, Drugstore Beetles, Earwigs, Firebrats, Grain Mites, Granary Weevils, Hide Beetles, Indian Meal Moths, Mediterranean Flour Moths, Red Flour Beetles, Rice Weevils, Saw-Toothed Grain Beetles, Silverfish, Small Flying Moths, Spider Beetles, Yellow Mealworms, Dried Fruit Beetles, Warehouse Beetles, Rusty Grain Beetles, Lesser Grain Beetles, Coffee Bean Weevils, Khapra Beetles and other listed insects. Apply as a surface application at a rate of 6 fluid ounces/1,000 sq. ft. Spray walls, floors and other surfaces, storage and handling areas thoroughly, being especially careful to treat cracks, crevices and similar hiding places. Or apply as a space spray at a rate of 1 fluid ounce/1,000 cu. ft. of space by directing the spray toward the ceiling and upper corners of the area and behind any obstructions. Do not reapply within 7 days. Do not apply more than 10 times to sweet potatoes. Do not apply both surface and space sprays within the same 7-day period.

AUTOMATIC SPACE SPRAY SYSTEMS: Use in automatic space spray systems to kill exposed accessible stages of: Small Flying Moths, Clover Mites, Cheese Mites, Cheese Skippers, Boxelder Bugs, Earwigs and the following common stored product pests: Granary Weevils, Rice Weevils, Confused Flour Beetles, Saw-Toothed Grain Beetles, Spider Beetles, Cigarette Beetles, Drugstore Beetles, Angoumois Grain Moths, Mediterranean Flour Moths, Indian Meal Moths, Tobacco Moths, Yellow Mealworms, Dark Mealworms, Grain Mites, Cadelles and Red Flour Beetles. Close room and shut off all air conditioning or ventilating equipment. Set system to apply undiluted concentrate at a rate of 0.5 to 1 fluid ounce/1,000 cu. ft. of space. Close off and vacate treated areas for at least 30 minutes and thoroughly ventilate before reoccupying. Do not apply more than once per day.

OUTDOOR APPLICATIONS, UNDILUTED:

To kill SMALL FLYING MOTHS

Best results are expected from application when the meteorological conditions favor an inversion of air temperatures in the area treated, and when the wind is not excessive. Apply only when wind speed is greater than or equal to 1 mph.

Do not apply more than 0.2 lbs pyrethrin/acre/year, or 2.0 lbs piperonyl butoxide/acre/year, whichever is lower, in any treated area. M

TEMPORARY REDUCTION, UNDILUTED, from SMALL FLYING MOTHS OUTDOORS. The aforementioned application for outdoor ground application will afford temporary reduction of annoyance from this pest in public gathering places (drive-in restaurants, drive-in theaters, golf courses, municipalities, sewers, parks, playgrounds and recreational areas). Direct application into tall grass, shrubbery and around lawns where this pest may hover or rest. Apply while air is still. Avoid wetting foliage. Application should be made prior to attendance.

FOR USE IN THERMAL FOGGING EQUIPMENT: Following the above directions and precautions. Apply at a rate of not more than 0.0025 pounds of pyrethrins and 0.0125 pounds of piperonyl butoxide per acre. For control of nuisance species in Texas, it may be necessary to use a dose of up to 0.008 pounds of pyrethrins and 0.04 pounds of piperonyl butoxide per acre.

In additional outdoor areas (corrals, feed lots, swine lots and zoos), fill area with mist directing application into tall grass, shrubbery and around lawns where these pests may hover or rest. Apply while air is still. Avoid wetting foliage. In zoos, avoid exposure of reptiles to the product.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **PESTICIDE STORAGE:** Store in original container in secured, dry storage area. Do not store above 100° F for extended periods of time. Storage below 32°F may cause freezing. If container is damaged or spill occurs, use product immediately or dispose of product and damaged container as indicated below. **PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site, in accordance with the label directions, or at an approved waste disposal facility. **CONTAINER HANDLING:** Nonrefillable container. Do not reuse or refill this container. Empty container by using the product according to the label directions. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: [(5 gallons or less) Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure 2 more times.] [(>5 gallons) Empty remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure 2 more times.] Then offer for recycling, if available, or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned stay out of smoke.
