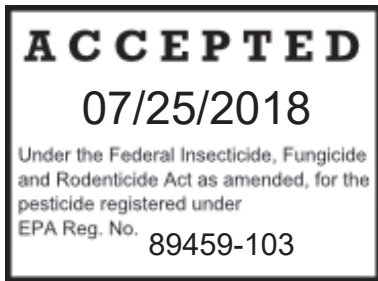

#### **ENVIRONMENTAL HAZARDS**

Only for formulation into an insect repellent for the following use(s): Residential and commercial indoor non-food areas.

This product may **NOT** be used to formulate products for the following uses: 1) food producing livestock - direct applications to meat and dairy animals, treatment of occupied premises or when animal food or feed is present; 2) growing crops -edible crops and pre- and post-harvest sprays; 3) fumigated commodities; 4) aquatic uses; or 5) human repellents.

NOTE: Repellent 326 may crystallize from exposure to temperatures below 70°F during shipment or storage. The drum may be filled with crystals or a layer of darker liquid over crystals. Warm drum gently to reliquify. Agitation and probing during warming will speed liquification. Do not heat above 120°F. Do not hold at elevated temperatures any longer than necessary. Agitate drum thoroughly before use. Mix well in drum before sampling and each use.
