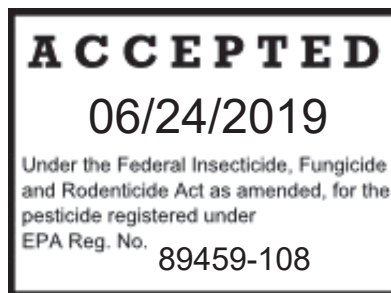

**STORAGE:** Store in original containers in a cool, dry place.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER HANDLING:** Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap.
