The preferred application time is at the end of the day once the animal is ready to rest. If used during the day, allow [product] to dry before turnout of the horse. Avoid applying [product] if you expect the animal to be outdoors during a heavy rain.

Keep people and pets out of the area during application. Exit area immediately and remain outside the treated area until sprays have dried.

Not for use on horses or foals intended for slaughter

Use to protect horses from house flies, stable flies, face flies, horn flies, gnats and mosquitoes. Also kills ticks and deer ticks that may transmit Lyme disease.

Shake well before using. Thoroughly brush the horse's coat prior to application to remove loose dirt and debris. For dirty horses, shampoo and rinse thoroughly. Wait until the coat is completely dry before applying.

This product may be applied either as a spray or as a wipe. Cover entire surface of animal with spray but avoid getting product into horse's eyes or other sensitive areas such as mouth or nose. For horse's face, always apply as a wipe using a piece of clean, absorbent cloth toweling (Turkish) or sponge. Wear rubber gloves or mitts when applying as a wipe. Spray or wipe horse's entire body while brushing against the lay of the coat to insure adequate coverage. Apply liberally for best results. Reapply every 5 to 7 days under normal conditions for initial applications. As protection builds, reapply every 10 to 14 days as needed. Make sure spray has completely dried before covering with any tack. Also, reapply each time animal is washed or exposed to heavy rain.

As a Spray: Remove excess dirt and dust. Spray the horse sufficiently to wet the surface of the hair while brushing lightly against the lay of the hair. Pay special attention to legs, belly, shoulders, neck, and facial areas. Avoid spraying in eyes and mucous membranes. Apply 1 fl. oz. per 100 pounds of body weight.

As a Wipe-On: Thoroughly brush horse to remove excess dirt and dust. Shampoo extremely dirty horses, rinse and allow to dry before applying wipe. Use a sponge or clean soft cloth or mitt. Apply 1 fl. Oz. per 100 pounds of body weight. Pay special attention to legs, belly, shoulders, neck, and facial areas. Avoid eyes and mucous membranes.

STORAGE and **DISPOSAL**: Do not contaminate water, food or feed by storage or disposal. **PESTICIDE STORAGE**: Store in original container in a dry place inaccessible to children and pets.
