For applications as a crack and crevice using supplied extension tube in actuator, apply product from a maximum distance of 12 inches at a rate of 1.5 seconds per linear foot. RESIDUAL GERMAN COCKROACH CONTROL: Hold can 12 inches from the surface to be sprayed. Spray a band in areas where German cockroaches generally crawl or reside in hidden
