

Changes made via label notification include:

- (Page 2) Correct the INACTIVE INGREDIENTS listing. At the last label amendment approval dated February 17, 2002, a cut and paste error resulted in an incorrect listing of ingredients. The correct listing is reflected on the original. registration (October 4, 2005), on the previous stamped-approved label (April 30, c 2007), and on subsequent label notifications (May 10, 2010 and August 8, 2014), c The correct listing is found on the attached with one additional modification (see c bullet below).
- (Page 2) In the INACTIVE INGREDIENTS listing, change "SD Alcohol 40" to read " "alcohol denat.", which is a more generic description of that ingredient.
- (Page 3) A related patent number is added.
