- 3. To clarify and define the quality assurance/quality control measures for this product, the following terms of registration are imposed. Submit these data within 90 days of the issuance date of this Notice of Pesticide Registration, except that 12 months are allotted for receipt of the batch analyses:
  - a) a manufacturing process amended to describe a method for identifying spores as Beauveria bassiana strain ANT-03;
  - b) batch analyses using viable count calculations;
  - c) specific methods for microbial contamination analyses;
  - d) defined rejection limits for contaminants; and
  - e) an explanation of unidentified fungi.
