The U.S. Environmental Protection Agency (EPA) is in receipt of your application for notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Biopesticides and Pollution Prevention Division (BPPD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The labeling submitted with this application has been stamped "Notification" and will be placed in our records. Additionally, the alternate brand name NOLI has been added to the product's records. You must submit one (1) copy of the final printed labeling with the modifications.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted-entry interval (REI) of 4 hours.

PRODUCT INFORMATION

KM1110 WDG is a water dispersible granule (WDG) that contains the yeast *Metschnikowia fructicola* strain NRRL Y-27328 and prevents post-harvest decay in certain fruit and berries caused by *Botrytis cinerea*, *Monilinia* spp., and *Rhizopus* spp. The product is intended for preventive treatment and must, therefore, be applied pre-harvest before disease symptoms appear. The product is intended for agricultural and greenhouse uses.

MIXING AND APPLICATION INSTRUCTIONS

Preparation of the Spray Suspension:

- 1. Fill tank ½ full with desired amount of water, as directed in Table 1 below. Start agitation to provide moderate circulation before adding KM1110 WDG.
- Add the directed amount of KM1110 WDG to the tank and the remaining volume of water and continue circulation.
- 3. Maintain circulation while loading and spraying.
- 4. Do not mix more KM1110 WDG than can be used within 24 hours.

Tank Mix Combinations:

Mixing the preparation in the spray tank with the following pesticides does not affect the vitality and activity of KM1110 WDG: sulfur preparations, kresoxim-methyl, polyoxin AL, neem oil, propamocarb, mancozeb, metiram, difenoconazole, cyprodinil + fludioxonil, dimethomorph, mefenoxam, chlorothalonil, maneb, fluazinam, potassium phosphite, and copper hydroxide.

Do not combine KM1110 WDG in the spray tank with other pesticides, surfactants, adjuvants, or fertilizers if there has been no previous experience or use of the combination to show it is physically compatible, effective, and non-injurious under your use conditions.

To ensure compatibility of tank-mix combinations, they must be evaluated prior to use. To determine the physical compatibility of this product with other products, use a jar test. Using a quart jar, add proportionate amounts of the products to one quart of water with agitation. Add dry formulations first, flowables and KM1110 WDG second, and emulsifiable concentrates last. After thoroughly mixing, let this mixture stand for 5 minutes. If the combination remains mixed or can readily be remixed, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients

to the spray tank. Observe the most restrictive of the labeling limitations and precautions of all products used in mixtures.

Pre-Harvest Application Instructions:

- Use ground equipment typical for making pesticide spray applications. Do not apply this product ٠ through any type of irrigation system.
- Spray when the humidity levels are highest such as in the early morning or evening.
- Ensure all plant parts are uniformly covered with spray solution to the point of first runoff.
- Do not allow the spray solution to go above 95°F (higher temperatures might reduce the quality of the . spray solution).
- Follow the specifications in Table 1 below with regard to crop, disease controlled, application rate and . frequency, spray volume, and application timing.

Do not spray when wind speed favors drift beyond the area intended for use. The pesticide must only be applied when the potential for drift to adjacent sensitive areas (e.g., residential areas, bodies of water, known habitat for threatened or endangered species, or non-target crops) is minimal (e.g., when wind is blowing away from the sensitive areas).
