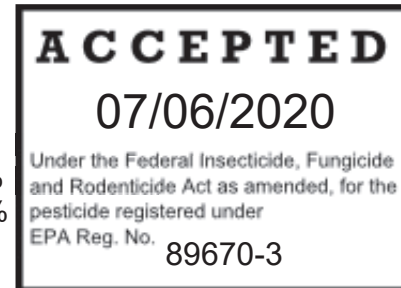

### **HAZARDS TO HUMAN AND DOMESTIC ANIMALS**

**Caution:** Harmful if swallowed. Causes moderate eye irritation. Wash thoroughly with soap and water after handling bait and before eating, drinking, chewing gum, using tobacco, or using the toilet. Avoid contact with eyes, skin, or clothing. Wear: long pants, socks, shoes and waterproof gloves when handling bait or dead rodents.

### **ENVIRONMENTAL HAZARDS**

This pesticide is toxic to birds, fish and other wildlife. Do not apply this product directly to water.

### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**IMPORTANT:** Do not expose children, pets, or non-target animals to rodenticides. To help to prevent accidents:

1. Store unused product out of reach of children and pets.
2. Apply bait in locations out of reach of children and pets, domestic animals and non-target wildlife or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from bait stations when they are lifted, units must be secured or otherwise immobilized. Stronger bait stations are needed in areas open to hooved livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
3. Dispose of product container and unused, spoiled, or unconsumed bait as specified on this label.

### **DO NOT USE THIS PRODUCT OUTDOORS**

This product may only be used to control house mice inside homes, industrial, commercial, agricultural and public buildings.

Burrow baiting is prohibited.

Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food or feed handling equipment, or milk or meat handling equipment or surfaces

**SELECTION OF TREATMENT AREAS:** Determine areas where house mice will most likely find and consume bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors or walls, or in locations where house mice and their signs have been seen. Remove as much alternative food and harborages (e.g., clutter piles, unused boxes, etc.) as possible.

**APPLICATION DIRECTIONS:**

- 1) Apply [two 10g] [or] [four 5g] sachets at each placement. For applications requiring a bait station, follow instructions for filling bait stations provided on the packaging.
- 2) After determining treatment area(s), apply bait every 8 to 12 feet (2.5 to 3.5 meters) along walls and corners where mice or their signs have been seen.
- 3) Regularly check the bait for signs of consumption. If no feeding occurs after three days, select new locations where house mouse activity is evident. Replace bait as necessary to maintain a constant supply of fresh bait for 21 days or until signs of house mouse activity cease.
- 4) Using waterproof gloves, collect and dispose of all visible dead animals and leftover bait properly.
- 5) To discourage re-infestation, limit sources of rodent food, water and harborage as much as possible. If re-infestation occurs, repeat treatment.
