#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Registration by the U. S. Environmental Protection Agency is required before the new product can be lawfully distributed in interstate commerce.

Only for formulation into a pre-plant soil fumigant for uses, users, and locations that at the time of the application qualify for exemptions under the Montreal Protocol (e.g., critical use exemption or quarantine and preshipment exemption uses) and for the following uses that do not qualify for exemptions: Peppers (grown for fresh market in CA), Tomato (grown for fresh market in CA), Caneberries (Raspberries, Blackberries, Boysenberries), Ginger (HI), Vidalia Onion (GA), Golf Course Tees, Greens, and Fairways, Athletic Fields, and Tobacco Seedling Trays. All end use products that contain *Directions for Use* for crops/use sites that at the time of the application do not qualify for exemptions under the Montreal Protocol or that are not listed above must be changed to remove those crops/use sites. All structural/space uses have been cancelled.

Methyl bromide formulated into end-use products containing 98% methyl bromide must contain directions for use only for the following uses: orchard replant; ornamentals (hot gas method only), forest seedlings, golf course tees, greens, and fairways (hot gas method only); athletic fields (hot gas method only); and quarantine uses. All other use sites and use patterns are prohibited and must be removed from the end-use product labeling.

Methyl bromide cannot be formulated into end-use products labeled for pre-plant uses without the use of tarps with the exception of California orchard replant for Critical Use Exemption (CUE) use using the deep broadcast application method and hand held tree-hole applications.

Methyl bromide cannot be formulated into end-use products labeled for pre-plant or pre-transplant uses unless the end-use registrant makes available to certified applicators who purchase or apply the end-use product a registrant developed training program approved by EPA. The registrant developed training program must be made available at least annually to the certified applicators. Methyl bromide cannot be formulated into end-use products labeled for pre-plant or pre-transplant uses unless the end-use registrant ensures Buffer Zone signs suitable for posting buffer zones, or templates for the buffer zone signs are available to its downstream distributors/customers who in turn will provide the signs at the point of sale.
