This MP product may be used in end-product pheromones for control of Navel orangeworm, *Amyelois transitella* if the formulator, user group, or grower has complied with U.S. EPA submission requirements regarding the support of such use.

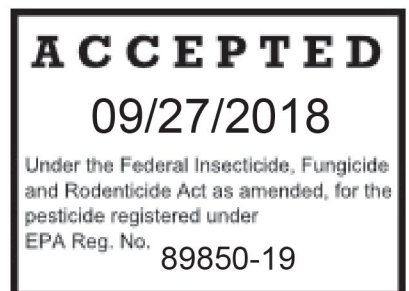
