The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

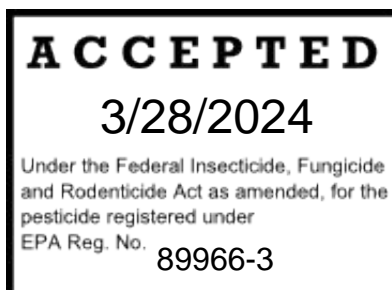

Only for formulation into a herbicide for the following uses: asparagus, bush and caneberry crop group, citrus fruits (Crop Group 10-10), cranberry, field corn, flax, grasses grown for seed, millet, oats, okra, pome fruit (Group 11-10), popcorn, production seed corn, rhubarb, silage corn, sorghum, stone fruits (Crop Group 12-12), sugarcane, sweet corn, tree nuts (Crop Group 14-12), and turfgrass (including golf courses, institutional, commercial and residential lawns and landscapes, sod farms, sports fields, parks, municipal grounds, and cemeteries).

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

Pesticide Storage: Keep container tightly closed when not in use. Keep away from heat and flame. Do not store near seed, fertilizers, or foodstuffs. Can be stored at temperatures as low as minus 20°F. Open dumping is prohibited.

Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into formulation equipment or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
