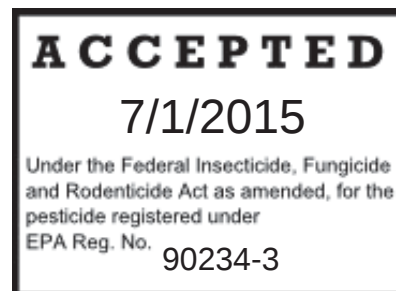

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this production a manner inconsistent with it's labeling. Read and follow all directions and precautions on this product label.

Hold container upright about 4 to 6 inches from skin or clothing and spray with a slow sweeping motion. [When using with a sunscreen, apply sunscreen first followed by the insect repellent [this product].] [If used in conjunction with a sunscreen, apply this product second.] Do not apply over cuts, wounds, or irritated or sunburned skin. Do not spray in enclosed areas. Do not use as a space spray. When using on children apply to your own hand and then put it on the child. Do not apply to children's hands. Do not allow children to handle this product. Use just enough repellent to cover exposed skin and/or clothing. Avoid over-application of this product. Frequent reapplication and saturation is unnecessary. [If biting insects do not respond to a thin film of repellent, apply a bit more.] After returning indoors, wash treated skin with soap and water. Wash treated clothing before wearing again. [For maximum protection: Spread evenly with hand to moisten all exposed skin.]

To apply to face: Spray palm of hand first and then apply sparingly and avoid eyes. Do not spray directly onto face. Do not apply near eye and mouth. Apply sparingly around ears.

Works on clothing too: Do not use under clothing. Spray shirts, pants, socks and hats. For ticks and chiggers, also spray to cuffs, socks and around other openings in outer clothing. Will not damage cotton, wool or nylon. Do not apply on or near acetate, rayon, Spandex or synthetic fabrics (other than nylon), furniture, plastics (such as eye glasses and watch crystals), leather and painted or varnished surfaces including automobiles.

STORAGE AND DISPOSAL

Pesticide Storage: Store away from heat or flame in an area inaccessible to children. Store in a cool, dry area, away from food and pet food.

Pesticide Disposal and Container Handling: Non-refillable container. Do not reuse or refill this container. Do not puncture or incinerate!
