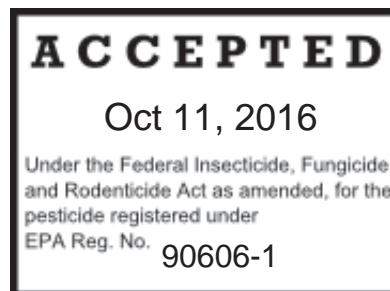

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. The product is designed specifically as a general cleaner and disinfectant for use in homes, hospitals, and commercial facilities. It is for use on hard, non-porous, inanimate environmental surface such as floors, walls, stainless steel, glazed porcelain, glazed ceramic tile, plastic surfaces, in bathrooms, shower stalls, bathtubs, and cabinets. May be used in the kitchen on non-food contact surface. In addition, this product deodorizes areas that are hard to keep fresh smelling including garbage cans, basements, restrooms and areas prone to odors.

DF-PRO is a binary (Two part) system. Before use, mix equal parts of PART A and PART B. Apply the newly mixed solution as a spray onto hard non-porous surfaces as directed below.

Surface Cleaning Procedures: Prior to application of DF-PRO as deodorizing and disinfection agent, gross filth, heavy soil, blood and other bodily fluids must be thoroughly cleaned from surfaces and objects before application of this product. Blood and other bodily fluids should be autoclaved and disposed of according to local

regulations and infectious waste disposal. Use appropriate personal protection when handling items exposed to blood and bodily fluids. To preclean a surface, spray the mixture (DF-PRO Part A and Part B) onto the surface and allow to penetrate (about 2 minutes), and then clean thoroughly.

Deodorizing and Disinfection: Follow surface cleaning instructions listed above to remove gross filth or heavy soil prior to disinfection. To disinfect and deodorize surfaces, spray the mixture (1 part DF-Pro Part A and 1 part DF-Pro Part B) onto the surface at a distance of 6-8 inches until thoroughly wet. Allow surface to remain wet for 10 minutes. Then let air dry.

When used as directed this product will kill *Pseudomonas aeruginosa* (ATCC 15442), *Salmonella enterica* (ATCC 10708) and *Staphylococcus aureus* (ATCC 6538) on contact.

Contact Time: Allow surface to remain wet for 10 minutes.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE – Store in a dry place. Do not allow product to freeze.

PESTICIDE DISPOSAL- To avoid wastes, use all material in this container by application, according to label directions. If wastes cannot be avoided, offer remaining product to a waste disposal facility or pesticide disposal program (often such programs are run by state or local governments or by industry).

CONTAINER DISPOSAL –

Nonrefillable Container (five gallons or less): Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Nonrefillable Container (greater than five gallons): Nonrefillable container. Do not reuse or refill container. Offer for recycling, if available. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.
