
Place the bait station [TC Mouse Killer 121-Purple] at point of highest activity beside burrows, along a wall, or in corners where signs of house mice have been seen. If additional units are to be used, place bait at 8-to 12-foot intervals. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are fresh signs of house mouse activity in infested areas. To monitor for replacement, view bait via seethrough lid. While wearing gloves, remove bait station if bait has been consumed or contaminated. Replace station with a new one if house mouse activity continues at that location.

Follow-up: Wearing gloves, collect and properly dispose of emptied bait stations or carcasses. Carcasses should be placed in an outdoor garbage can. To discourage re-infestation, eliminate food, water and harborage as much as possible. If re-infestation does occur, repeat treatment.





2. Placing Bait Stations




Place the bait station horizontally or vertically at the point of highest activity beside burrows, along a wall, or in corners where signs of house mice have been seen. If additional units are to be used, place bait stations at 8- to 12-foot intervals.

3. Monitor



Maintain an uninterrupted supply of fresh bait for at least 15 davs or until there no longer are fresh signs of house mouse activity in infested areas. To monitor for replacement, view bait via see-through lid. While wearing gloves, remove bait station if bait has been consumed or contaminated. Replace station with a new one if house mouse activity continues at that location

4. Follow Up



Wearing gloves, collect and properly dispose of any emptied bait stations and/or carcasses. Carcasses should be placed in an outdoor garbage can. To discourage re-infestation, eliminate food, water and harborage as much as possible.

If re-infestation does occur, repeat treatment.




