EXCIRA is a plant growth regulator specially designed to enhance sugar content or starch production for the crops listed below.

Do not tank mix with agrichemical products that are alkaline in nature. Final spray mixture below pH 7.0 is beneficial for uptake. If tank mix partners do not allow an acid solution, follow the most restrictive label. Always make a sample of EXCIRA and other products to determine tank mix compatibility prior to application.

Mix the specified amount of EXCIRA in water to create a 1.0% solution and apply with sufficient volume for uniform and thorough coverage of foliage and/or fruit. Refer to the specific mixing rates in the table below.
