### PRODUCT INFORMATION

This product CHB-ST(GI), containing two plant growth regulators IBA and gibberellic acid, is a seed treatment for crops and grasses grown for seed production. When applied according to the use directions and rates on this label, CHB-ST(GI), stimulates seed germination and promotes faster and more uniform stand establishment.

NOTE: For best results, read all directions for use thoroughly. Consult your local experiment station specialist, distributor, or the field representative in your area for the spray schedule best suited to your conditions. Do not use with other seed treatment products unless previous experience assures compatibility.

**Note:** Use only as directed. The label must be read thoroughly and understood before making applications. Compatibility: CHB-ST(GI) is compatible with most commonly used seed treatments. To ensure the compatibility of this product with other products, pour the products into a small container of water in the correct proportions. After thorough mixing, let stand for 5 minutes. If the combination remains mixed, or can be remixed readily, the mixture is compatible.

## RESTRICTIONS

**On-Farm Seed Treatment**: Do not apply this product through any type of irrigation system. Do not use treated seed for food or feed purposes or process for oil. Do not store excess treated seeds beyond planting time. Seed treatment on agricultural establishment at or immediately before planting is within the scope of WPS, while commercial treatment of seeds is not within the scope.

**For Commercial Seed Treatment**: Seed treated commercially or for sale must be dyed an unnatural color using an EPA-approved dye before sale.

**Tank Mixing**: When tank mixing, follow the most restrictive label instructions for any tank mix partner. Do not tank mix with any product that contains a prohibition against tank mixing.

## SEED BAG LABELING REQUIREMENTS

Seed commercially treated with this product must be labeled in accordance with all applicable requirements of the Federal Seed Act. The user of this product is responsible for ensuring that the seed bag meets all requirements under the Federal Seed Act.

THE FEDERAL SEED ACT REQUIRES THAT BAGS CONTAINING TREATED SEEDS BE LABELED WITH THE FOLLOWING STATEMENTS:

This seed has been treated with CHB-ST(GI) (Gibberellic acid & 3-Indolebutyric acid (IBA). Do not use for feed, food, or oil purposes.

THE US ENVIRONMENTAL PROTECTION AGENCY REQUIRES THE FOLLOWING STATEMENTS ON BAGS CONTAINING SEEDS TREATED WITH CHB-ST(GI):

Store treated seed away from feed or foodstuffs.

Do not allow children, pets, or livestock to have access to treated seeds.

Do not use the same auger for treating seed that will handle commercial or feed grains.

Wear long pants, long-sleeved shirt, shoes plus socks, and chemical-resistant gloves made of any waterproof material when opening this bag or handling (e.g., loading, pouring) treated seed.

After treated seed has been planted, do not enter or allow worker entry into areas planted with treated seeds during the restricted-entry interval (REI) of 4 hours.

**EXCEPTION**: Workers may enter these areas without restriction if there will be no worker contact with the soil/media subsurface. Treated seed exposed on soil surfaces may be hazardous to wildlife. Cover or collect treated seed spilled during loading and planting.

Do not contaminate bodies of water when disposing of planting equipment washwater. If excess treated seed remains after planting, dispose of it by burying away from bodies of water. Do not store leftover treated seed where there is a chance of it becoming mixed with untreated seed.

Store treated seed in cool, dry conditions.

Dispose of treated seed packaging in accordance with local requirements.

Excess treated seed may be used for ethanol production only if (1) by-products are not used for livestock feed and (2) no measurable residues of pesticides remain in the ethanol by-products that are used in agronomic practice.

CHB-ST(GI) may be applied to the following crops to optimize germination and emergence, especially when seed is planted under cool soil conditions. CHB-ST(GI) should be applied as a slurry in a total volume of 4 to 12 fluid ounces/100 lb of seed; volumes greater than 10 fluid ounces/100 lb may be needed to optimize coverage. Do not apply CHB-ST(GI) to seed or water prior to a 24-hour presoak.
