#### **PRODUCT INFORMATION**

Templar is a product for air-borne and soil-borne disease suppression and to enhance abiotic stress resistance of listed food crops. Salicylic acid helps in reducing disease development and thus, allows better management of yield and quality for production of crops.

Always make a sample of Templar and other products to determine tank mix compatibility prior to application.

For all crops, unless otherwise specified, tank mix Templar by adding 25.6 fluid ounces per 100 gallons of water and spray crop canopy with sufficient volume to ensure uniform coverage. Refer to the specific mixing rates in the table below.

Templar has no direct activity against plant pathogens. Templar contains systemic compounds that function to stimulate the plants natural defenses and support vigorous growth. A 0.2% v/v (1 gallon per 500 gallons of carrier) solution of Templar provides the optimum concentration for best performance. Templar works best when applied before disease signs or symptoms appear. Uniform and thorough spray coverage is essential for best performance. Templar combined

with a suitable fungicide program provides an optimal disease defense system. Plant health and plant growth are both amplified.

Do not apply if rain is expected within 2 hours of application. If sufficient rain to wash leaf occurs within 2 hours of application, re-apply. Compatibility has not been fully determined for all agrochemicals.

Due to reduced coverage with gallonage of 5 gallons per acre or less, aerial application requires a minimum dose of 2.6 oz/acre (see footnote (3) below).
