FIRST AID

If swallowed:

Use Deer Ban Repellent Capsules to repel deer.

General: Animals use urine to communicate in the wild. When they repeatedly smell a predator's odor, animals conclude it's a dangerous place and choose instead to move elsewhere. Deer Ban Repellent Capsules create the illusion that coyotes are present in your lawn or garden, so deer won't invade your lawn and garden.

Application Directions

Use Restrictions

This product is not for direct application to plants intended for human consumption (i.e. food plants). Apply only to the perimeter of where food plants are grown to create a repellent barrier. Do not open capsules or disperse contents directly onto plants intended for food use.

Disperse one capsule every 10 to 20 feet around your garden or flowerbed perimeter, ensuring there is a capsule on every outside corner. Do not open capsules or disperse contents directly onto ground. One capsule application lasts 30-90 days.

Deer Ban Repellent kits contain: 20, 50, or 150 Deer Ban Repellent Capsules. Replacement: Replace capsules as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

Storage: Store in a cool, dry place.

Container Handling: If empty: Non-refillable container. Do not reuse or refill this container. Place in trash or offer for recycling if available. If partially filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
