The amended label and CSFs referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, are acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them. Per issuance of this registration, the **data requirements for storage stability and corrosion characteristics (Guidelines 830.6317 and 830.6320) are not satisfied.** You have 18 months from the date of this letter to provide these data.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Further, should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

ATTENTION

A225.06 is extremely phytotoxic to certain apple varieties.

Extreme care must be used to prevent injury to apple trees (and apple fruit).

DO NOT spread **A225.06** where granules may reach apple trees.

DO NOT apply when weather conditions favor product blowing from treated areas to nontarget aquatic habitat.

INTEGRATED PEST (DISEASE) MANAGEMENT

A225.06 should be integrated into an overall disease and pest management strategy whenever the use of a fungicide is required. Cultural practices known to reduce disease development should be followed. The DIRECTIONS FOR USE section in this label identifies specific IPM recommendations for each crop. Consult your local agricultural, turf authorities for additional IPM strategies established for your area. **A225.06** may be used in State Agricultural Extension advisory (disease forecasting) programs which recommend application timing based on environmental factors favorable for disease development.

RESISTANCE MANAGEMENT

For resistance management, please note that A225.06 contains both a Group 3 (propiconazole) and Group 11 (azoxystrobin) fungicide. Any fungal population may contain individuals naturally resistant to A225.06 and other

Group 3 or Group 11 fungicides. A gradual or total loss of pest control may occur over time if these (fungicides) are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

To delay fungicide resistance, take one or more of the following steps:

- Rotate the use of **A225.06** or other Group 3 or Group 11 fungicides within a growing season sequence with different groups that control the same pathogens.
- Use tank mixtures with fungicide from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes scouting, uses historical
 information related to pesticide use, and crop rotation, and which considers host plant resistance, impact
 of environmental conditions on disease development, disease thresholds, as well as cultural, biological and
 other chemical control practices.
- Where possible, make use of predictive disease models to effectively time fungicide applications. Note that using predictive models alone is not sufficient to manage resistance.
- Monitor treated fungal/bacterial populations for resistance development.
- Contact your local extension specialist or certified crop advisor for any additional pesticide resistancemanagement and/or IPM recommendations for specific crops and pathogens.
- For further information or to report suspected resistance contact Atticus, LLC. You can also contact your pesticide distributor or university extension specialist to report resistance.

In situations requiring multiple applications, develop season-long programs for Group 11 (QoI) fungicides. In crops where two sequential Group 11 fungicide applications are made, they should be alternated with two or more applications of a fungicide that is not in Group 11. If more than 12 applications are made, observe the following guidelines:

- When using a Qol fungicide as a solo product, the number of applications should be no more than 1/3 (33%) of the total number of fungicide applications per season.
- For Qol mixes in programs in which tank mixes or premixes of Qol with mixing partners of a different mode of action are utilized, the number of Qol containing applications should be no more than ½ (50%) of the total number of fungicide applications per season.
- In programs in which applications of QoI are made with both solo products and mixtures, the number of QoI containing applications should be no more than ½ (50%) of the total number of fungicides applied per season.

If a Group 11 fungicide is applied to the seed or soil, **DO NOT** make another application with a Group 11 fungicide for at least 3 weeks.

Integrated Pest (Disease) Management (IPM): Sound turf management resulting in healthy, vigorous turf is the foundation of a good IPM program. Cultural practices such as proper choice of turf variety, nutrient management,

proper cutting height, thatch management, and proper watering, drainage, and moisture stress management should be integrated with the use of fungicides to increase turf vigor and reduce the susceptibility to disease. Immunoassay detection kits and extension service diagnostic services can assist in the early and accurate identification of causal organisms and corresponding selection of the proper fungicide when required.

MANDATORY SPRAY DRIFT

Groundboom Applications:

- User must only apply with the release height recommended by the manufacturer, but no more than 4 feet above the ground or crop canopy.
- Applicators are required to use a medium or coarser droplet size (ASABE S572.1).
- Do not apply when wind speeds exceed 15 miles per hour at the application site.
- Do not apply during temperature inversions.

SPRAY DRIFT ADVISORIES

THE APPLICATOR IS RESPONSIBLE FOR AVOIDING OFF-SITE SPRAY DRIFT.
BE AWARE OF NEARBY NON-TARGET SITES AND ENVIRONMENTAL CONDITIONS.

IMPORTANCE OF DROPLET SIZE

An effective way to reduce spray drift is to apply large droplets. Use the largest droplets that provide target pest control. While applying larger droplets will reduce spray drift, the potential for drift will be greater if applications are made improperly or under unfavorable environmental conditions.

Controlling Droplet Size - Ground Boom

- Volume Increasing the spray volume so that larger droplets are produced will reduce spray drift. Use the
 highest practical spray volume for the application. If a greater spray volume is needed, consider using a
 nozzle with a higher flow rate.
- Pressure Use the lowest spray pressure recommended for the nozzle to produce the target spray volume and droplet size.
- Spray Nozzle Use a spray nozzle that is designed for the intended application. Consider using nozzles designed to reduce drift.

BOOM HEIGHT - Ground Boom

Use the lowest boom height that is compatible with the spray nozzles that will provide uniform coverage. For ground equipment, the boom should remain level with the crop and have minimal bounce.

SHIELDED SPRAYERS

Shielding the boom or individual nozzles can reduce spray drift. Consider using shielded sprayers. Verify that the shields are not interfering with the uniform deposition of the spray on the target area.

TEMPERATURE AND HUMIDITY

When making applications in hot and dry conditions, use larger droplets to reduce effects of evaporation.

TEMPERATURE INVERSIONS

Drift potential is high during a temperature inversion. Temperature inversions are characterized by increasing temperature with altitude and are common on nights with limited cloud cover and light to no wind. The presence of an inversion can be indicated by ground fog or by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions)

indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing. Avoid applications during temperature inversions.

WIND

Drift potential generally increases with wind speed. AVOID APPLICATIONS DURING GUSTY WIND CONDITIONS. Applicators need to be familiar with local wind patterns and terrain that could affect spray drift.

APPLICATION INSTRUCTIONS

Apply **A225.06** at rates and timings as described in this label. **A225.06** may be applied with all types of spreader equipment commonly used for making ground applications excluding belly grinder equipment. Proper adjustments and calibration of application equipment to give good coverage is essential for good disease control. The higher rates in the rate range and/or shorter application intervals may be required under conditions of heavy infection pressure, highly susceptible varieties, or when environmental conditions conducive to disease exist.

TURF

A225.06 is directed for control of certain pathogens causing foliar, stem, and root diseases, including leaf and stem blights, leaf spots, patch diseases, mildews, anthracnose, fairy rings, molds, and rusts of turfgrass plants. **A225.06** may be used to control certain diseases on turf in golf courses, lawns and landscape areas around residential, institutional, public, commercial and industrial buildings, parks, recreational areas and athletic fields.

Restrictions:

- **DO NOT** apply more than 19.2 lb. product (0.144 lb propiconazole and 0.060 lb azoxystrobin)/1000 sq. ft./calendar year.
- **DO NOT** apply more than 5 lb. product (0.038 lb propiconazole and 0.016 lb azoxystrobin)/1000 sq. ft. in a single application.
- **DO NOT** make more than 4 applications per year.
- Minimum retreatment interval: 14 28 days
- DO NOT apply more than two sequential A225.06 applications for *Pythium* spp. control. For all other diseases when *Pythium* spp. is not present, DO NOT apply more than three sequential applications of A225.06.
- **DO NOT** exceed 3 lb. product (0.023 lb propiconazole and 0.009 lb azoxystrobin)/1,000 sq. ft. every 30 days on any variety of bermudagrass. Bermudagrass can be sensitive to **A225.06**.
- In Florida, DO NOT apply A225.06 to bermudagrass golf course greens when temperatures exceed 90°F.
- **DO NOT** graze or feed clippings from treated turf areas to animals.
- **DO NOT** apply by air or chemigation. Application must be made by ground only.

Application Timing: A225.06 should be applied prior to disease developing.

ADDITIONAL INFORMATION – TURFGRASS FROM SEED

For use in the establishment of turfgrass from seed or in overseeding of dormant turfgrass:

A225.06 may be used for control of certain turfgrass diseases associated with turfgrass establishment from seed. **A225.06** may also be used during overseeding of dormant turfgrass.

A225.06 may be safely applied before or after seeding or at seedling germination and emergence to ryegrass, bentgrass, bluegrass, and fescue turfgrass types. **Note:** Optimum application timing is during seeding. See Application Directions section.

Rate Ranges: Use the shorter specified application interval and/or use the higher specified rate when prolonged favorable disease conditions exist.
