The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped “NOTIFICATION” and placed in our records.

A109.06 can be used on beef and dairy cattle (including lactating) of all ages and sizes. Treatment for flies can be repeated as needed but not more often than once every 3 weeks. For optimal lice control, an initial application followed by a second treatment 3 weeks later is recommended.

A109.06 does not control cattle grubs.
