It is manufactured for incorporation into End-Use Products, intended to control the Fall Armyworm (*Spodoptera frugiperda*), as well as other Lepidoptera. This Manufacturing Use Product is not for direct treatment of pests. End-use mating disruption products formulated from this product must be registered by the US EPA.

Do not use from damaged, punctured or unsealed containers.
