Optional Label Claims and Marketing Statements

The use of Carbon Dioxide as a pesticide is consistent with the protocols and ideologies of Integrated Pest Management (IPM). IPM is a process which is used to manage all types of pests. It combines management approaches for greater effectiveness that include biological control, cultural controls, mechanical controls and chemical controls.
