The amended label referred to above, submitted in connection with EPA Registration No. 91275-1, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and removes use on citrus crop group 10-10 from the previous version of this registration's master label, consistent with the Ninth Circuit's decision in *Migrant Clinicians Network v. EPA*, 88 F.4th 830 (2023). Sale and distribution of this product continues to be subject to EPA's March 4, 2024 order governing stocks that had been released for shipment as of February 5, 2024. Accordingly, this amendment merely aligns the master label with the current registered uses for this registration.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. 
claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.
