The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Deltamethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. #### [Option #1 for Extruded collars]

Place collar around dog's neck, adjust for fit, and buckle in place. The collar must be worn loosely to allow for growth of the dog and to permit the collar to move about the neck. Generally, a properly fitted collar is one that when fastened, will snugly slide over the dog's head. Leave 2 or 3 inches for extra adjustment. Cut off and dispose of excess length. Wash hands after [installing] [placing] collar on dog. Replace collar every [6][six] months.

#### [Option #2 for Injection molded collars]


[Remove the collar from its packaging, separate the Peel-Away Comfort Strip and place in the trash.] Place collar around dog's neck and buckle in place [with the main clasp. Feed excess collar through the remaining two clasps for extra hold and a clean fit]. Adjust the collar for a snug fit to create contact between the collar and the dog's hair/coat for better product release and diffusion. A properly fitted collar will allow two fingers to be placed

between the collar and dog's neck. The elasticity of the collar is designed to stretch in the event that the dog becomes entangled. Leave an excess of 1-2 notches [(1/4 to  $\frac{1}{2}$  inch)] past the last clasp. Adjust periodically for growing dogs. Cut off and dispose of excess length. Wash hands after [installing] [placing] collar on dog. Replace collar every [6][six] months.


#### [Option #3 for Injection molded collars]

Do not open until ready to use. Dust [will] form on collar during storage. Do not get dust in mouth or eyes. Take the collar out of the packaging and stretch to full length. [The tabs that held the collar in place [should][will] fall off when stretching; pull on any remaining tabs to remove them.]

Bend the buckle in half between the holes in the buckle, so that you can easily pass the end of the collar through both holes.



Place the collar around your dog's neck. Feed the collar through both holes [[ridges][notches] facing out]. Fit to the neck of the dog. Generally, a properly fitted collar is one that, when fastened, will snugly slide over dog's head and two fingers can be placed between the collar and dog's neck. Leave [2 or 3] [1 or 2] extra inches for collar adjustment, cut off remaining excess collar and dispose of in the trash.



Wash hands after [installing] [placing] collar on dog. Replace collar every 6 months.




