Dear Ann M. Tillman:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. The Agency, in accordance with the FIFRA, as amended, has also completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Novaluron Final and/or Interim Decision, and has concluded that your submission is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.



Feed the specified dosage of [novaluron] [brand name] [this product] to each horse separately to make certain it receives the full ration. Feed this product daily, top dressed on grain or mixed with the horse's total rations, to provide 25 mg of novaluron per 100 lbs [45.4 kg] body weight. For occasional finicky eaters who do not accept new feeds readily, mix [brand name] [this product] with sweet feed or grain rations.

Dosage and Administration for Control of House Flies and Stable Flies

Begin feeding in the spring before flies begin to appear and continue feeding throughout the summer and into the fall until cold weather inhibits fly development.

Bulk: Using scoop supplied with the product, mix one (1) scoop in the horse's ration every day for horses weighing less than 1,100 lbs. For horses over 1,100 lbs mix two (2) scoops of [brand name] in the horse's ration every day.

{The following directions apply if the product is in pre-packaged pouches} [Pre Measured Pouches- Daily feed one 0.88 oz pouch for horses under 1,100 lbs. Daily feed two pre-measured 0.88 oz pouches for horses weighing more than 1,100 lbs.]

Feed one 0.88 oz daily ration in combination with Horse Logic supplements daily pack. Each daily supplement combination will weigh between 2 oz and 10 oz per daily pack depending on the supplement combination. Feed one Horse Logic Daily Pack +[brand name] feed through fly control per day for horses weighing under 1,100 lbs.]]

[brand name][this product] contains novaluron, an [insect growth regulator][IGR] which prevents the development of house flies and stable flies in the manure of treated horses but is not effective against existing adult flies.

Significant results may be observed within 2 weeks.

In some cases, supplemental fly control measures may be needed in and around paddocks and buildings to control adult house and stable flies which can breed in decaying vegetable matter or silage on premises or migrate in from other areas.


