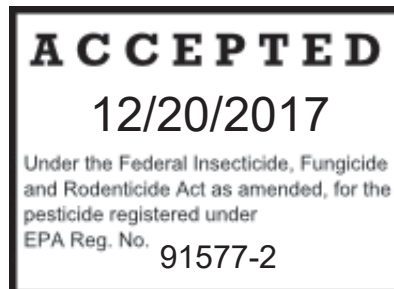

Hazards to Humans and Domestic Animals

To Disinfect Hard Non-Porous Surfaces

Floors, walls, sinks, bathtubs, showers, vinyl, tile, and appliances: Flush drain, if applicable. Disinfect with a solution of $\frac{3}{4}$ cup of this product per gallon of warm water, thoroughly wetting surfaces. Let stand on surface for 10 minutes, then rinse.

Toilet bowls: Flush toilet to remove heavy soil. Pour 1 cup of this product into bowl. Brush entire bowl including under the rim with a brush, sponge or mop. Let stand for 10 minutes, then flush.

Kitchen sink: Cover stains with 1 gallon of water before adding $\frac{3}{4}$ cup of this product. Let stand on surface for 10 minutes, then rinse.

To Clean and Deodorize

Garbage/Trash Cans: After washing and rinsing thoroughly, brush inside with a solution of $\frac{3}{4}$ cup of this product per gallon of water. Let air dry or drain.

Laundry Use

Brighten Whites / Remove Stains / Control Odors (Deodorize)

Safe for bleaching whites and most color-fast washables (acrylics, cotton, nylon, polyester, and rayon). Avoid bleaching wool, silk, mohair, leather, spandex, non-fast colors and flame retardant cotton fabrics.

Bleach Test: To check if garment is bleach-safe, apply one drop of a solution made of 2 tablespoons of this product in $\frac{1}{2}$ cup of water to a hidden part of the fabric. Check all colors including trim. Let stand 1 minute, then blot dry. No color change means the article can be safely bleached.

- 1) Sort laundry by color.
- 2) Fill washer, then add 1 cup of this product.
- 3) Add detergent and then laundry.

Pretreat Stains and Soils: Remove loose soil. Fully soak garment in a solution of $\frac{1}{4}$ cup of this product in 1 gallon of cold water, for 5 minutes. Then rinse and wash as usual.

STORAGE AND DISPOSAL

Pesticide Storage:

Store away from children. Reclose cap tightly after each use. Store this product in a cool, dry area away from direct sunlight and heat to avoid deterioration. In case of spill, flood area with large quantities of water.

Pesticide Disposal:

Product or rinsates that cannot be used should be diluted with water before disposal in a sanitary sewer.

Container Handling:

Nonrefillable container. Do not reuse or refill this container. Recycling empty container or discard in trash.
