This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.



(Maxttrac® is a lure designed to attract mosquitoes to traps where they die [including those mosquitoes which may transmit [Zika virus, West Nile virus, Encephalitis and Chikungunya virus]). Replace the lure after thirty [30] days of use.

1. Disconnect power supply.
2. Using a pen (or similar object), pierce through the aluminum film on the cap.

3. Insert the attractant [cartridge] [lure] into the attractant holder on the trap. *[Make sure the cap portion of the attractant is facing the front.] [Picture or Illustration].*
4. Replace [cartridge] [lure] after 30 days of use. For best results use this lure in Dynatrap DT160.
