DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

For use by manufacturers only as an antimicrobial treatment. For the control of mildew, odor causing bacteria and fungi that may affect the integrity of the treated textiles used in the manufacture of mattress tickings. Also as a microbiostat preservative for the following aqueous compositions: latices, non-food contact adhesives, casein/rosin dispersions which are then used in the manufacture of carpet underlays, carpet backing and upholstery undersides.

DILUTION RATE AND APPLICATION

Use 1.0 to 2.0 % of the Sanitized® Brand TB 83-35 product per 1000 gallons.

Mattress Ticking:

Use a concentration of 1.0 to 2.0% of the Sanitized® Brand

TB 83-35 product, relative to the dry weight of the fabric/textile/material being treated.

Latices: (polymers, synthetic, rubber)

Use a concentration of 0.3 to 1.5 % of the Sanitized® Brand

TB 83-35 product, relative to the total weight of the material being treated.

Adhesives: (NON-FOOD CONTACT)

Use a concentration of 0.3 to 1.5 % of the Sanitized® Brand

TB 83-35 product, relative to the total weight of the material being treated.

Casein/Resin:

Use a concentration of 0.3 to 1.5 % of the Sanitized® Brand

TB 83-35 product, relative to the total weight of the material being treated.

Use only to treat carpet-backing. Not for use in carpet fibers.

Treated plastics cannot be used to manufacturer children's toys.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.
