Cilantro, Corn, Cotton, Beet (garden, leaves), Peanuts, Beans, Peas, Lentils, Horseradish, Potatoes, Pumpkin, Rhubarb; Safflower, Sorghum (sweet, grain or forage), Soybeans, Soybean (immature, seed), Sugar beet, Sunflower, Tomato, Cabbage, Pepper (bell, chile, cubanelle, tabasco), Alfalfa grown for seed, Celery, Onions (dry bulb), Meadowfoam grown for seed, Radishes grown for seed (excluding daikon), Buffalograss, Guymon Bermudagrass for seed production, Nurseries, Turf, Landscape plantings, Peaches, and Established grasses grown for seed.

Formulators using this product are responsible for obtaining EPA registration of their formulated products.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Open dumping is prohibited. Wastes resulting from the use of this product are toxic. Improper disposal of unused pesticide is a violation of Federal law. Pesticide that cannot be disposed of according to label instructions must be disposed of according to federal, state, or local procedures. ### **Container Disposal:**

#### **Container Handling [less than 5 gallons]**

Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use and disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

#### **Container Handling [greater than or equal to 5 gallons]**

Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration.

**Container Handling [Refillable Container (greater than 55 gallons)]:** Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10% full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times. For final disposal, offer for recycling or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
