Dear Ms. Clemmer:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. 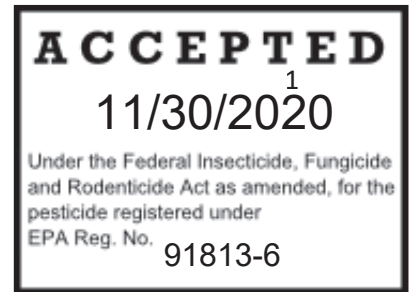

(1) The following uses: Asparagus; Brassica Group 5-16; Cotton; Cucurbit vegetables (crop group 9); Fallow Cropland; Peas; Peppermint tops; Peppers; Rhubarb; Rice; Snap Beans (succulent); Soybeans including immature soybeans (edamame); Spearmint tops; Sugarcane; Tobacco; Tuberous and corm vegetables, except potato (subgroup 1D).

(2) Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration.

(3) Use for experimental purposes that are in compliance with USEPA requirements.

Formulators using this product are responsible for obtaining USEPA registration for their formulated product which may be labeled for the use patterns as found listed on this label.

STORAGE AND DISPOSAL

Do not contaminate other pesticides, fertilizers, water, food or feed by storage or disposal.

Pesticide Storage

Do not store below 25°C. Product may crystallize at temperatures below 25 °C (77 °F). In the event that crystallization occurs, the material may be melted at temperatures not to exceed 85°C (185°F). Store in original containers only. Store in a dry place and avoid excess heat. Carefully open containers. After partial use, replace lids and close tightly. Do not put concentrate or dilute material into food or drink containers.

In case of a spill, avoid contact, isolate area and keep out animals and unprotected persons. Confine spills. Call CHEMTREC (Transportation and Spills): 800-424-9300.

To confine spill: Dike surrounding area or absorb with sand, cat litter, or commercial clay. Place damaged package in a holding container. Identify contents.

Pesticide Disposal

Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

Container Handling

Metal Isotainers. Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. Clean and rinse with detergent and water as follows: empty the remaining contents into a holding drum and continue to drain for 10 seconds after the flow begins to drip. Insert pressure rinsing nozzle in the side

of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Metal Drums: Nonrefillable container. Do not reuse or refill this container. Triple rinse or pressure rinse container promptly after emptying. Triple Rinse: Empty the remaining contents into a storage container or a mix tank. Fill the container $\frac{1}{4}$ full with appropriate solvent(1). Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into a storage container for later use or disposal, or into a mix tank for product formulation. Repeat this procedure two more times. Pressure rinse: Empty the remaining contents into a storage container or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold the container upside down over storage container or mix tank or collect rinsate for later use or disposal. Inset pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Then offer for recycling if available or reconditioning if appropriate or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.

(1) An appropriate solvent would include a solvent that will dissolve technical material. The rinsate may be used later to formulate a product or may be disposed in accordance with local, state and national environmental laws, rules, standards and regulations.
