The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the lambda-cyhalothrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

# **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Formulators using this product are responsible for obtaining EPA registration for their formulated product.

Only for formulation into an insecticide, for the following uses:

(1) **Terrestrial and Aquatic Food**: Alfalfa; Brassica (head and stem) (Subgroup 5A); Canola; Corn (field, pop, seed and sweet); Cotton; Cucurbit Vegetables (Group 9); Fruiting Vegetable (Group 8); Garlic; Grass Forage, Fodder and Hay (Group 17); Legume Vegetable (edible podded) (Subgroup 6A); Lettuce (head and leaf); Oat, Barley, Buckwheat and Rye; Onion (dry bulb); Pea and Bean (dried and succulent) (Subgroups 6B and 6C); Peanuts; Pistachio; Pome Fruits (Group 11); Rice and Wild Rice; Sorghum; Soybean; Stone Fruit (Group 12); Sugarcane; Sunflower; Tree Nut (Group 14); Triticale and Wheat; Tuberous and Corm Vegetable Group (Subgroup 1C)

### **CONTAINER HANDLING:**

# [for Nonrefillable fiber drums with liners]

Nonrefillable container. Do not reuse or refill this container.

Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment, then offer for recycling if available or dispose of in a sanitary landfill or by incineration. If drum is contaminated and cannot be reused, dispose of it in the manner required for its liner.

# [for Nonrefillable paper and plastic bags]

Nonrefillable container. Do not reuse or refill this container.

Completely empty bag into application equipment, then offer for recycling if available or dispose of empty bag in a sanitary landfill or by incineration.

# [for Nonrefillable plastic containers]

Nonrefillable container. Do not reuse or refill this container.

Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ½ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into application equipment or mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side

of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip

Then offer for recycling if available or puncture and dispose of in a sanitary landfill or by incineration or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

### [for Refillable plastic containers]

Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose

Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller.

To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
