For larger areas to be protected, multiple devices may be required. Once the package is opened, [this product] [the PIRK] emits Transfluthrin, an insecticidal product that creates a vapor field that will kill mosquitoes, stable flies, and sand flies. After an initial 2 hour diffusion period, this device will achieve knockdown of mosquitoes and sand flies within 2 hours of exposure. Use this product in the following areas: tents, stables, recreational vehicles, campers, port-a-potties, garages, and kennels. Not for use in farm structures or buildings housing food-producing animals or poultry.

## Installation Instructions

Remove [product] [PIRK] from the packaging, avoid touching the treated surface. Retain packaging for product storage between treatment locations and for product disposal. The device is ready to use! Hang from the [loop] [ceiling hook] [using self-adhesive string] [enclosed] or place on a table out of the reach of children. 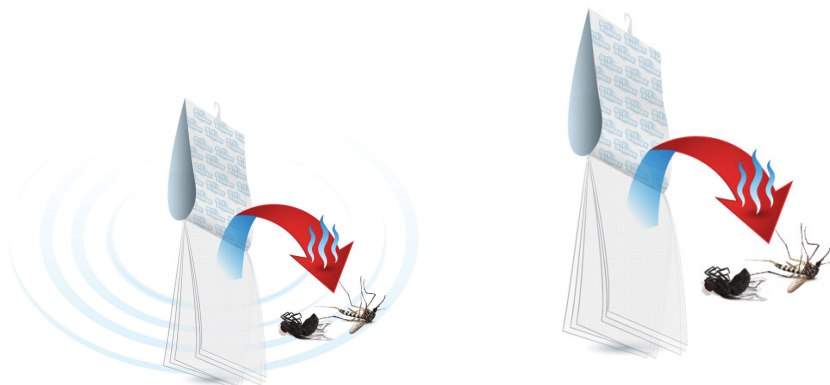

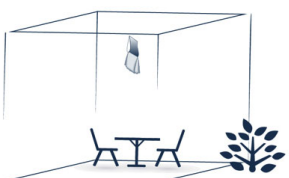
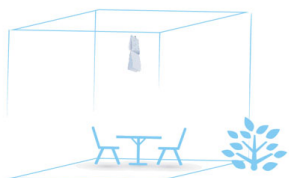
