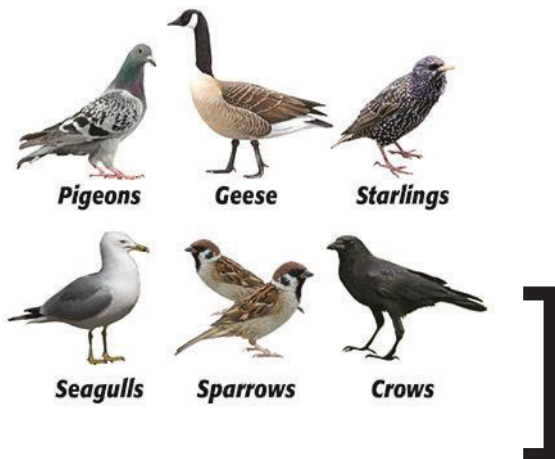

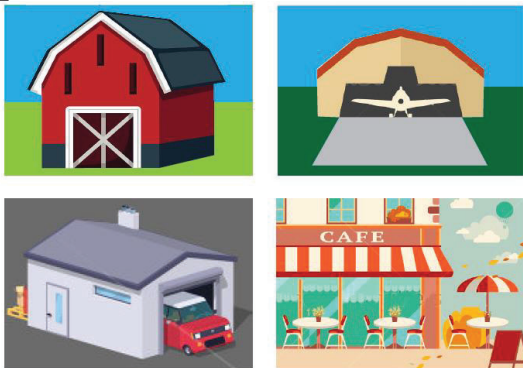

In the State of New York, areas where the above types of wild birds or their droppings and humans or domestic birds come in close contact pose a risk to human health and in these settings, birds are considered pests. For use on or near domestic structures or buildings, Rejex-it® Fog Force™ AR20 should only be dispensed when no human or non-target animals are at risk of direct exposure to the application.

Do not smoke while applying this product. Use precautionary measures to limit direct exposure to humans, pets, domestic animals or non-target wildlife. Do not apply directly to plants, painted structures, or other valuable property to avoid damage or discoloration. Do not apply to the point of drench.

Do not apply this product to food crops.

When applying via fogger or hand spray, monitor bird activity and reapply the product as needed until desirable results are achieved.

Do not apply toward active breeding areas or brooding birds.

USE RESTRICTIONS IN THE STATE OF NEW YORK ONLY

Fogging application must be done by certified applicators. Applicators must use a dust/mist filtering respirator (MSHA/NIOSH) approval number prefix TC-21C), or a NIOSH approved respirator with any N, R, P, or HE filter. A minimum separation distance equal to 100 ft or the windward length of the proposed treatment area, whichever is greater, is required between the outer perimeter of the proposed area and any adjacent area of natural bird habitat such as a clump of trees, wood lot, forested area, etc. The automated aerosol dispensers fogger must be shut off when the Rejex-it® Fog Force™ AR20 bearing fog has reached the downwind perimeter of the treatment area or sooner if the birds have been repelled.

AUTOMATED USE

USE RESTRICTIONS: For use in Avian Fog Force TR Branded dispensers. Only for outdoor use and in buildings with openings that permit bird access.

APPLICATION DIRECTIONS: Place spray nozzle in the direction of the space to be protected or expected approach of birds so that birds are exposed to bursts of fog. Turn actuator on and leave the unit at the location until no birds are returning. If placed in a protected outdoor location, we suggest that the Time Set be set to 7.5 (one spray every 7 ½ minutes) and the Mode be set to "DAY" (daylight hours only). If located indoors, we suggest that the Time Set be set to 15 (one spray every 15 minutes) and the Mode be set to "24" (24 hours). Keep the spray nozzle directed away from any object, painted surface, and especially plants and shrubbery to avoid discoloration or damage from direct contact with Rejex-it® Fog Force™ AR20. In addition, do not allow product to accumulate to the point of runoff on any desirable surface. When mounting Avian Fog Force TR Branded dispenser, place it in a location where it will not directly spray humans or non-target animals.

HAND HELD

USE RESTRICTIONS: Only for outdoor use and in buildings and/or structures with openings that permit bird access.

APPLICATION DIRECTIONS: Place spray nozzle in the direction of the target pest or expected approach of birds so that birds are exposed to bursts of fog. Point nozzle away from face, other people, and animals. Hold can on a slight downward angle. For best results, spray when air is calm. Avoid applying when wind speed exceeds 10 miles per hour. Allow a few minutes for product to take effect. Do not apply toward active breeding areas, brooding birds, or apply if distance to target pest exceeds 25 feet.

Keep the spray nozzle at least 5 feet from, or nozzles directed away from, any object, painted surface, and especially plants and shrubbery to avoid discoloration from direct contact with Rejex-it® Fog Force™ AR20. Do not allow product to accumulate to the point of runoff on any desirable surface. Do not smoke while applying this product.

INDOOR FOGGING APPLICATIONS (SHEDS, GARAGES, ETC.)

Apply Rejex-it® Fog Force™ AR20 at a rate not to exceed one (1) ounces per 10,000 cubic feet of space to be treated. Point the spray can nozzle or the spray dispenser nozzle in the general direction of the nuisance birds. Keep the nozzle at least 5 feet from any structure or object to allow for complete dissipation of the fog. Expose as many birds as possible to the fog for fast and lasting results. For hand held application, several treatments 1 to 4 days apart may be required for removal of all nuisance birds. For automated dispenser applications, set the spray interval for 2-5 second fogging pulses during the time of expected bird activity.

OUTDOOR FOGGING APPLICATIONS

General Application Directions

Apply Rejex-it® Fog Force™ AR20 at a rate of 3 to 4 ounces per 10,000 sq. ft. of area to be treated. Point the spray can nozzle or the spray dispenser nozzle in the general direction of the nuisance birds. Keep the nozzle pointed away from and at least five feet from any structure or object to allow for complete dissipation of the fog. For hand held application, several treatments 1 to 4 days apart may be required for removal of all nuisance birds. For automated dispenser applications, set the spray interval for 2-5 second fogging pulses during the time of expected bird activity.

Trees and Shrubs, Patios and Decks:

Apply Rejex-it® Fog Force™ AR20 as directed in the General Application Directions, above. Expose as many birds as possible to the fog for fast and lasting results. Rejex-it® Fog Force™ AR20 should be applied when birds have settled down. Withhold treatment until conditions favoring successful use arise (temperature, direction, and speed of wind). For best results, make applications in the evening when most of the birds have arrived but before it gets too dark for the birds to leave once exposed to the fog. Applications in the morning when the birds normally leave the trees or shrubs does not have much effect. To prevent damage to foliage, do not allow Rejex-it® Fog Force™ AR20 to accumulate to the point of runoff.

Lawns:

Apply Rejex-it® Fog Force™ AR20 as directed in the General Application Directions, above. Applications may be done at any time of day when birds are present. To control Canada geese, apply at any time when they are feeding or roosting, except when they sit on a nest during breeding season.

Ornamental Fountains, Ornamental Ponds, and Other Similar Man Made Materials:

Do not apply directly to water. However, it is expected that overspray may occur. Apply when wind and drift conditions are minimal. Apply Rejex-it® Fog Force™ AR20 as directed in the General Application Directions, above. Spray upwind of target pests so that the wind will carry the fog in the general direction of the birds. For roosting birds, the product is best applied in the evening when most of the birds have arrived but before it gets too dark for the birds to leave.

STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

PESTICIDE STORAGE: Store only in original container in a dry place in accessible to children, pets, and domestic animals.

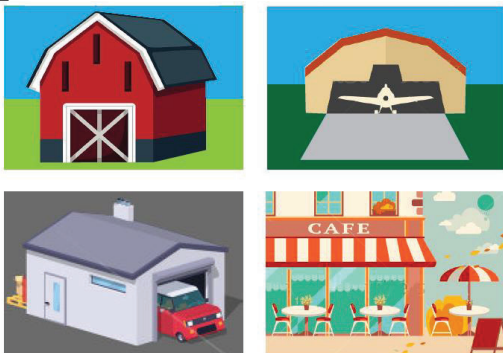
