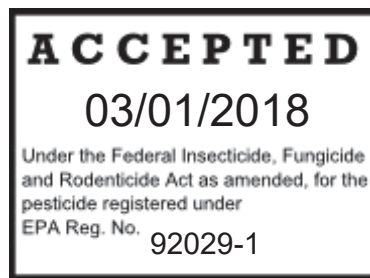

Storage and Disposal
