<b>BEFORE YOU USE</b> Read and follow directions when using.	<b>RESTRICTIONS:</b> <ul style="list-style-type: none"><li>• This product is a ready-to-use granule formulation of Imidacloprid intended to kill termites (including subterranean termite species of <i>Reticulitermes</i> and <i>Coptotermes</i>).</li><li>• Determine distance in feet around your home. This 9.0 lb container will treat a home 100 - 200 linear feet in distance (6 inches wide).</li><li>• If active subterranean termite infestations continue to occur in the area where the treatment was made, it is recommended that a licensed pest control operator be contacted for treatment (see Guarantee).</li><li>• Applications must not be made when areas are waterlogged, snow covered, or frozen.
