The label submitted with the application has been stamped “Notification” and will be placed in our records.

### FOR INDUSTRIAL USE

## DILUTE BEFORE USING

Mix one gallon of Woodtreat® 10 with 50 to 2,000 gallons of aqueous treating solution depending on the application system, type of lumber and performance required. Use this product ONLY in combination with Kop-Coat's sapstain control products. For specific recommendations, contact Kop-Coat Technical Service.

## GENERAL INFORMATION

**Description:** This product may ONLY be used as an end-use additive to Kop-Coat Sapstain Control Products to boost performance against targeted fungi that discolor or degrade freshly cut lumber and other similar wood products.

## STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**Storage:** Store in a closed, properly labeled container in a cool place. If static generating conditions exist, provide necessary grounding and bonding. Keep containers closed when not in use.

**Pesticide Disposal:** Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

**Container Handling:** Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available.
