The Antimicrobials Division (AD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

DILUTE BEFORE USING

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

This preservative is recognized as effective for above ground use and not recommended for ground contact. Woodlife® 111 4:1 Concentrate is intended for use on new lumber, plywood, particleboard, waterboard, millwork and similar type of wood products.

This clear oil solution has been developed for the protection of wood against fungus growths which cause rot, mold and decay. It also contains water repellents to aid in control of shrinking, swelling, end checking, grain raising and warping.

For best results, this product must be diluted and applied so as to effect maximum penetration into wood and heavy absorption especially at joints and wherever end grain exists. A three minute immersion period for millwork. For other open tank treatments, completely immerse the wood in solution for five minutes per inch of thickness. For the control of dimensional changes, shrinkage and swelling, the treatment of the end grain is most important since the moisture pickup there is a hundred to a thousand times greater than at the flat or edge grain surface for many species of wood. Vacuum or pressure assisted treating in a closed system will result in deeper penetration.

Estimated Coverage: 5 to 15 gallons per thousand board feet for open tank treatment. 200 square feet per gallon for brush application.

Dilution Instructions: Dilute under gentle agitation.

On-site use: For normal exposure situations such as for AWPA, use Categories 1, 2, or 3A, dilute one part of this concentrate with four parts by volume of an appropriate petroleum-based solvent such as mineral spirits or VM&P Naptha. For more severe exposure requiring greater protection, dilute one part of this concentrate with 1.5 to 3 parts by volume of an appropriate petroleum based solvent.

Reformulation: Dilute Woodlife* 111 4:1 Concentrate with mineral spirits or other appropriate petroleum based solvent to achieve the desired active ingredient level per EPA registered label for the diluted product. The repackager is responsible for obtaining an EPA registration for the ready-to-use product to be made from the concentrate prior to sale of the diluted product.

Compatibility: This product is compatible with other products designed for millwork protection including Timbertreat* ICP-5. Contact Kop-Coat, Inc. for details.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store in a closed, properly labeled container in a cool place. If static generating conditions exist, provide necessary grounding and bonding. Keep containers closed when not in use.

Pesticide Disposal: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law. If these wastes con not be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance.

Container Handling: Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth ensuring at least one complete revolution for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available.
