It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

- 1- Look for and eliminate all standing water around your home. Standing water can be found in places such as bird baths, flowerpots, toys and gutters.
- 2- Aedes Mosquito Killers should be spaced 35 feet apart in shaded areas around the property to reduce Aedes mosquitoes. Do not exceed 10 units [pots] [containers] [Aedes Mosquito Killers] per acre. [Each unit [pot] [container] [Aedes Mosquito Killer] contains 0.1 g of permethrin. Do not exceed 1.0 g permethrin per acre.]
- 3- [Pour] Add [118 oz] water into each Aedes Mosquito Killer. Do not exceed the height of the overflow hole. Add water to Aedes Mosquito Killers as necessary if evaporation occurs.
- 4- Replace Aedes Mosquito Killers once a month [every 4 weeks] [if needed]. Aedes Mosquito Killers will no longer hold water when they are ready to be replaced.
