PRODUCT INFORMATION

AgriDiatomSil is a completely organic mineral product derived from Diatomaceous Earth. It is very effective to control crawling insects that have an exoskeleton. When AgriDiatomSil comes in contact with the insects, the sharp edges lacerate the insect's waxy exoskeleton and then the powdery material absorbs the body fluids and dehydrates the insects. This product is for agricultural use only.

ALL APPLICATIONS

Mix 2 kgs (4.4 lbs) of AgriDiatomsil in 200 liters (53 gallons) of water and spray it over 1 acre of area before the foliar stage. Repeat the application every 10 days.

In case of rain, mix with an adherent to prevent being washed away. Care must be taken to constantly agitate the tank to prevent the solids from sinking to the bottom. However, the preferred route of application is by using an electrostatic negative-charge ionizer to coat the entire plant, especially making it stick and stay put underneath the leaves.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a cool dry place.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
