Do not open protective pouch until ready to use. Do not let children play with this collar.

Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling.

Do not use on puppies under 12 weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant, medicated, or nursing animals. Sensitivities may occur after using ANY pesticide products for pests. If signs of sensitivity occur, remove collar and bathe your pet with mild soap and rinse with large amounts of water. If sings continue, consult a veterinarian immediately.

This collar is intended for use only as an insecticide for external use on dogs and is not to be taken internally by man or animals. Applying other pesticides on the dog may not be necessary while the collar is being worn.

	FIRST AID

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Wipe the collar with a damp cloth prior to application. Place the collar around dog's neck, buckle and adjust for proper fit. Cut off approximately 2 inches from the buckle and dispose of excess length by wrapping in newspaper and placing in trash. The collar must be worn loosely so that two fingers may be placed between collar and dog's neck. Maximum effectiveness may not occur for 2-3 weeks after collar placement. Living and rest areas of pet must also be treated with appropriate pest control measures to ensure control of pests. Wetting will not impair the collar's effectiveness or the pet's protection. If the dog goes swimming or is out in the rain, it is not necessary to remove the collar. Neoterica Protecto Delta may be used in addition to a lead or constraint collar. Use only one Neoterica Protecto Delta at a time. This collar should be worn continuously. Reapply a new collar every 6 months.
