

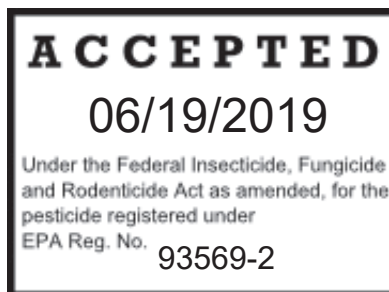

Only for formulation into a herbicide for the following uses:

Asparagus; Berry, group 13; Fruit, citrus, group 10-10; Cranberry; Corn (field, popcorn, seed production, silage, sweet); Flax; Grasses grown for seed; Millet (pearl, proso); Oats; Okra; Fruit, pome, group 11-10; Rhubarb; Sorghum (grain and sweet); Soybean; Fruit, stone, group 12-12; Sugarcane; Nut, tree, group 14-12; and Turfgrass (including golf courses, institutional, commercial and residential lawns and landscapes, sod farms, sports fields, parks, municipal grounds, and cemeteries)

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

**Pesticide Storage:** Keep container tightly closed when not in use. Keep away from heat and flame. Do not store near seed, fertilizers, or foodstuffs. Can be stored at temperatures as low as minus 20°F. Open dumping is prohibited.

Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

**INNER LINER:** Completely empty removable liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into formulation equipment.
