Treated plants will turn from green to brown or black usually as fast as [1/3/6] hours. Larger or more difficult to control plants may take longer to develop symptoms. Development of symptoms occurs fastest in warm sunny conditions. For best results, spray coverage should be uniform and complete. Plants should be actively growing less than five inches in size and not covered with soil or heavy dew. Some weeds will require multiple applications every 2-3 weeks for complete control.
