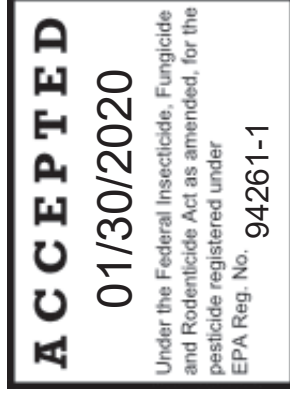

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

LIMITED TO CRACK AND CREVICE TREATMENTS ONLY

To apply paste: Remove cap and securely screw in plastic tip. Touch tip to surface and squeeze. Paste can be applied only as a line along cracks or crevices. Apply paste only in areas that are not easily accessible to children and pets. Apply paste at a rate of 3 grams/per square foot. After use, remove plastic tip and recap tube after use. Inspect paste after 14 days and reapply if no longer visible. Paste cleans up with a damp paper towel. Discard towel in trash after use.

FOOD AREAS:

(Restaurants, Food Processing and Food Handling Establishments, Dining Rooms, Kitchens, etc.) Includes areas where food or feed is received, stored, prepared, served, packaged (canning, boxing, or wrapping), handled in an enclosed system and where edible waste is stored. Do not deposit this product on serving surfaces where food and feed stuff are processed or exposed. Do not contaminate exposed surfaces where food contact can occur. Apply behind and under the following: stoves, ovens, refrigerators, freezers,

dishwashers, sinks, counters, shelving, water pipes, around pipe collars, drains, sewers, cracks and crevices of baseboards, in corners of cupboards, cabinets and closets. Remove drawers from chests and cabinets, apply freely into corners of drawer wells. Reapply as necessary. Pack all visible paste into cracks and crevices. Remove excess paste from exposed surfaces using a damp paper towel and dispose into garbage. Do not contaminate food and feed stuffs.

SERVING AREAS:

(Dining Rooms, Mess Halls and other areas where prepared food is served) Apply paste to surfaces such as baseboards, underneath booths and into crack and crevices. Do not contaminate exposed surfaces where food contact can occur.

NON-FOOD AREAS:

(Garbage Rooms, Rest Rooms, Laboratories, Offices, Locker Rooms, Boiler and Equipment Rooms, Garages, Mop Closets and Storage Areas) Apply to cracks and crevices, around baseboards, water and drainpipes, underneath and around sinks, washing machines, and tubs.

Do not apply paste to areas that have recently been sprayed with insecticide, and do not spray insecticide over paste as it may cause the bait to become repellent.

RESISTANCE MANAGEMENT

For resistance management, CUCKOL contains a Group 8D insecticide. Any insect population may contain individuals naturally resistant to CUCKOL and other Group 8D insecticides. The resistant individuals may dominate the insect population if this group of insecticides are used repeatedly in the same areas. Appropriate resistance-management strategies should be followed. To delay insecticide resistance, take the following steps:

- Rotate the use of CUCKOL or other Group 8D insecticides during the year with different groups that control the same pests.
- Adopt an integrated pest management program for insecticides use that includes scouting, uses historical information related to pesticide use, record keeping, and which considers cultural, biological, and other chemical control practices.
- Monitor after application for unexpected target pesticide survival. If the level of survival suggests the presence of resistance, consult with your local university specialist or certified pest control advisor.

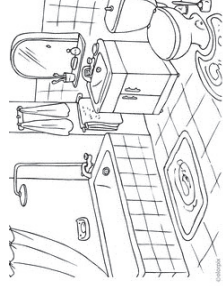
