This product may only be used to formulate products for use during the baling process if appropriate baler equipment is used which prevents exposure of non-target organisms to the formulated product.

#### **Product Restrictions:**

**Do not** formulate into end-use products for pre-harvest hay and straw, cut hay and straw in the field prior to baling.

Do not use this product on hay and straw after baling.

### **Product Labeling Requirements for Formulated Products:**

The following label language must appear on any end use product formulated from this product.

"This product may only be used during the baling process if appropriate baler equipment is used which prevents exposure of non-target organisms to this product. Apply product to the hay and straw as it is fed into the baler, using the rates on this label. The baler application equipment must prevent drippage and drift and must function properly and be used/maintained in accordance with the manufacturer's written operation instructions. **Do not** apply to pre-harvest hay and straw, cut hay and straw in the field prior to baling. **Do not** use this product on hay and straw after it has been baled."

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

#### **Product Storage:**

Keep away from heat and open flame. Keep container closed during storage.
