[{FRACTURING} {FRAC}] FLUIDS: {(Not Approved For Use In California)} Add this product to the frac water storage tanks or directly into the well head injection pipeline as the water is being pumped down-hole.

**PACKER FLUIDS:** {(Not Approved For Use In California)} This product is to be added to the packer fluid at a point of uniform mixing such as a circulating holding tank {and} {other mixing device locations}. Add 0.2 - 4.4 gal. of this product per 1,000 gal. {(0.64 – 15.36 gal. of this product per 100 barrels)} of freshly prepared packer fluid {(167 – 4,488 ppm of product)} {(24 – 528 ppm active Glutaraldehyde) (3.6 – 79.2 ppm DDAC/2.4 – 52.8 ppm ADBAC) (6 – 132 ppm total active Quaternary)}. Levels for effective control vary depending on conditions at the site and the severity of contamination. Seal the treated packer fluid in the wall between the casing and the production tube.
