OIL FIELD, GAS PRODUCTION AND TRANSMISSION PIPELINE AND SYSTEMS

{[FRACTURING] {FRAC}} FLUIDS: {(Not a use registered by California)} This product reduces bacterial contamination and degradation of fracturing fluids and gels used in oil and gas well stimulations. Add this product to the frac water storage tanks or directly into the well head injection pipeline as the water is being pumped down-hole. Dose Range: This product should be added at a rate of 35 to 700 ppm actives (1 - 20 gallons per 10,000 gallons) depending on the degree of bacterial fouling in the source water.

DRILLING, COMPLETION, AND WORKOVER FLUIDS: {(Not a use registered by California)}

This product should be added to a drilling fluid system at a point of uniform mixing such as the circulating mud tank.

Initial Treatment: Add 0.5 – 10.0 gal. of this product per 10,000 gal. of freshly prepared fluid (17.5 – 350 ppm actives).

Maintenance Dosage: Add 0.5 – 10.0 gal. of this product per 10,000 gal. of freshly prepared fluid (17.5 – 350 ppm actives).

PACKER FLUIDS: {(Not a use registered by California)}

This product should be added to a packer fluid at a point of uniform mixing such as a circulating holding tank. Add 0.5 – 6.0 gal. of this product per 10,000 gal. of freshly prepared packer fluid (17.5 – 210 ppm actives). Levels for effective control vary depending on conditions at the site and the severity of contamination. Seal the treated packer fluid in the wall between the casing and production tube.

Injections to the system should be weekly, or as needed to maintain control.

GAS PRODUCTION AND TRANSMISSION PIPELINE SYSTEMS: {(Not a use registered by California)}

This product should be added to a gas production or transmission line via direct injection. The application should be conducted to ensure maximum distribution of this product throughout the entire internal pipeline surface by adding a sufficient amount of biocide to detect/measure a residual concentration at the back end of the pipeline system. Criteria for success of the treatment will be a reduction in bacterial counts and/or reduced corrosion rates. To facilitate application, it may be desirable to dilute this product with an appropriate solvent immediately before use. The concentration in the solvent should not fall below an active concentration range of 500 to 5,000 ppm based on the volume of water in the pipeline. Injections to the system should be weekly, or as needed to maintain control.

GAS STORAGE WELLS AND SYSTEMS: {(Not a use registered by California)} Treat individual injection wells with 6 – 64 oz. of this

product per 100 gal. of water (175 – 1750 ppm actives). Update treatment rate as needed. This product must be diluted by the water present in the formation. Injection takes place before gas is injected and may be repeated yearly or as needed to maintain control. Individual drips should be treated with a sufficient quantity of this product to produce an active concentration of 200 to 2000 ppm of this product when diluted by the water present in the drip. Injections should be repeated yearly or as needed to maintain control.

HYDROTESTING: {(Not a use registered by California)} Treat water used to hydrotest pipelines or vessels by adding 0.1 – 8 gallons of this product per 1,000 gal. of water (15 – 1200 ppm actives), depending on water quality and length of time the equipment will remain idle.

PIPELINE PIGGING AND SCRAPING OPERATIONS: {(Not a use registered by California)} Add this product to a slug of water immediately following the scraper (ideally this water volume can be kept to a minimum and contained between the scraper and a trailing pig). 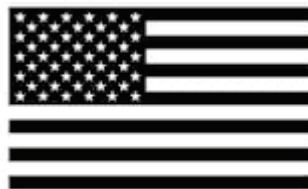
