Repeat this procedure two more times.] Then offer for recycling if available or reconditioning, if appropriate, or puncture and dispose of in a sanitary landfill or by other procedures allowed by State and local authorities.]

Pressure rinse as follows: Empty the remaining contents into formulating equipment and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over formulating equipment or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.
